Gentlemen:

In accordance with Rule 5 (B) of the Northwest portion of Order No. R-1670, El Paso Natural Gas Company hereby submits its application for administrative approval of a non-standard gas proration unit consisting of Lots 3, 4, 5, 6 of Section 20, Township 31 North, Range 11 West, San Juan County, New Mexico, and in support thereof states the following facts:

- 1. The Mudge #28, located 890' from the South line and 1650' from the East line of Section 20, Township 31 North, Range 11 West, was completed as a gas well in the Pictured Cliffs Formation on November 18, 1965.
- 2. That the proposed non-standard proration unit consists of 151.62 acres which is less acreage than a standard proration unit.
- That the proposed non-standard gas proration unit consists of contiguous quarter-quarter sections and lots.
- 4. That the proposed non-standard gas proration unit lies wholly within a single government section.
- 5. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
- 6. That by a copy of this letter of application all operators owning interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit and (b) in acreage offsetting the non-standard gas proration unit, are notified by registered mail of this non-standard gas proration unit.

Therefore, El Paso Natural Gas Company requests that under the provisions of Rule 5 (B) of Order No. R-1670, the Secretary of the Commission grant exception to Rule 5 (A) without Notice and Hearing and approve the subject non-standard gas proration unit.
