Pursuant to NMAC 19.15.15.13, Mewbourne Oil Company applies for approval of an unorthodox oil well location for the following well:

<u>Well:</u>	Long Draw 9 BO Fed. Com. Well No. 1
<u>Surface location:</u>	330 feet FSL & 2270 feet FEL §4
<u>Entry point at top of Yeso:</u>	130 feet FSL & 2270 feet FEL §4
<u>Beginning of producing interval:</u>	330 feet FNL & 2270 feet FEL §9
<u>Bottom hole location:</u>	330 feet FSL & 2270 feet FEL §9
<u>Well unit (project area):</u>	W½E½ of Section 9, Township 20 South, Range 25 East, N.M.P.M., Eddy County, New Mexico

The well will be drilled to a depth sufficient to test the North Seven Rivers Glorieta-Yeso Pool. The pool is spaced on statewide rules, with 40 acre spacing, and wells to be located no closer than 330 feet to a quarter-quarter section line. A Form C-102 is attached as **Exhibit A**.


Although the well penetrates the top of the Glorieta-Yeso formation at an unorthodox location in Unit Letter O of Section 4, the productive (perforated) interval of the wellbore will be at an orthodox location in Unit Letter B of Section 9. Placing the surface location to the north of the well unit will maximize the productive length of the wellbore.

Due to the well's directional plan, the entry point in the Yeso is in the S½ of Section 4. That acreage is operated by Mewbourne, and Devon Energy Production Company, L.P. is the only other working interest owner. **Exhibits B and C**. Notice of the application has been given to Devon Energy Production Company, L.P. **Exhibit D**.


