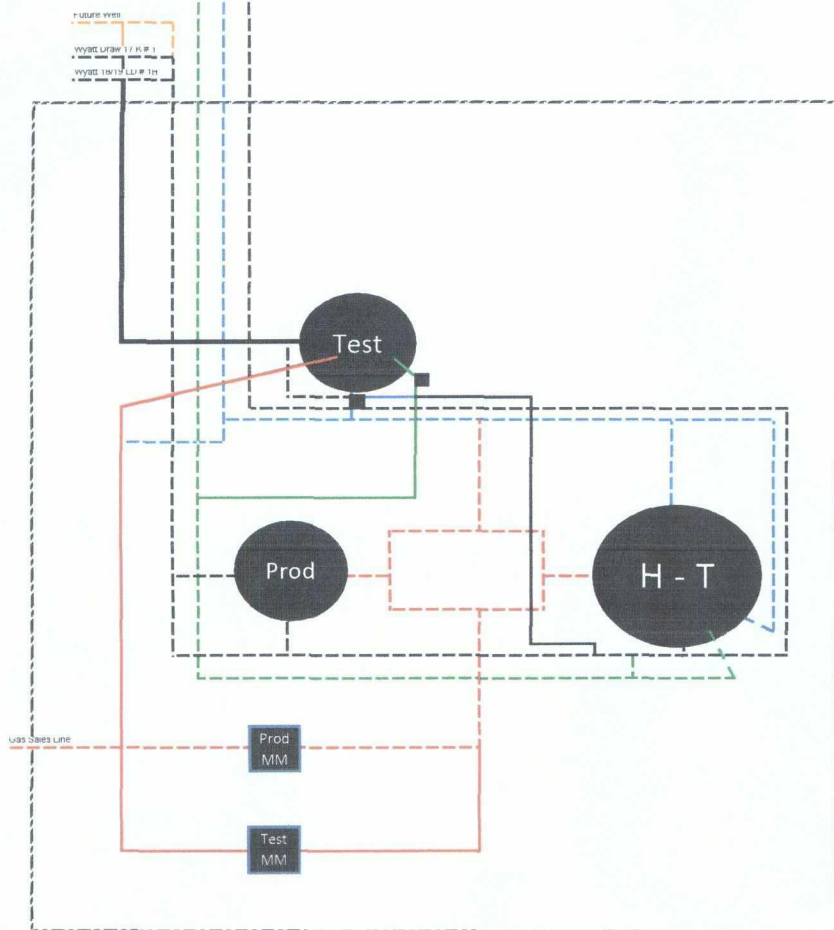
# Wyatt Draw "17 K Battery Test & Production Separation Equipment

All oil and water from the test separator goes into the heater treater after passing through their respective flow meters. The gas from the test separator goes through it's own meter then feeds into the production gas meter then goes to Lease Master Meter.

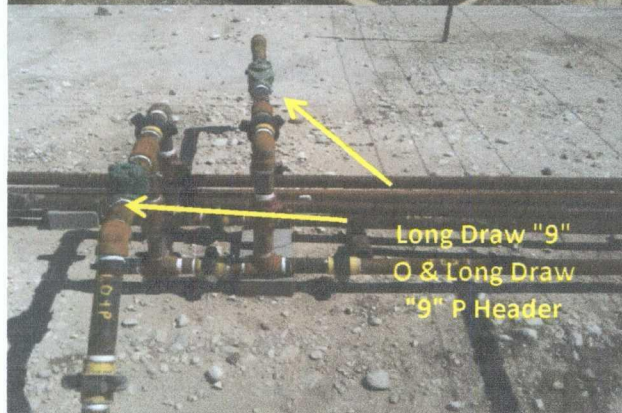
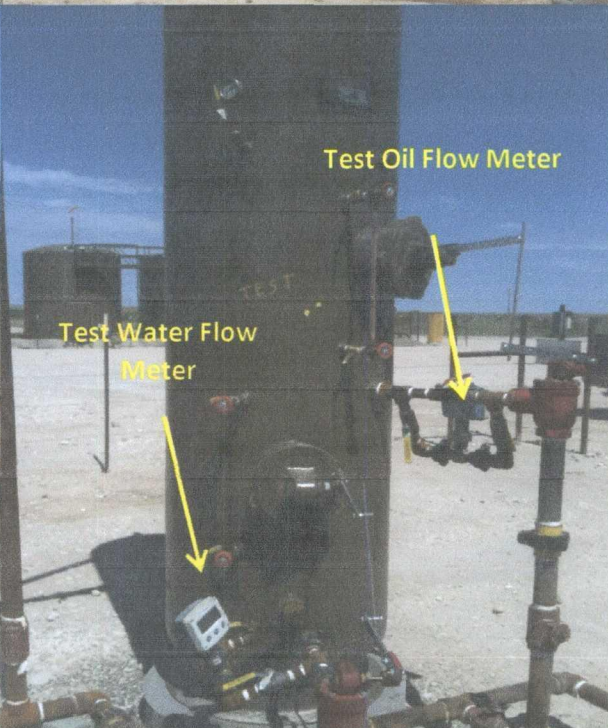
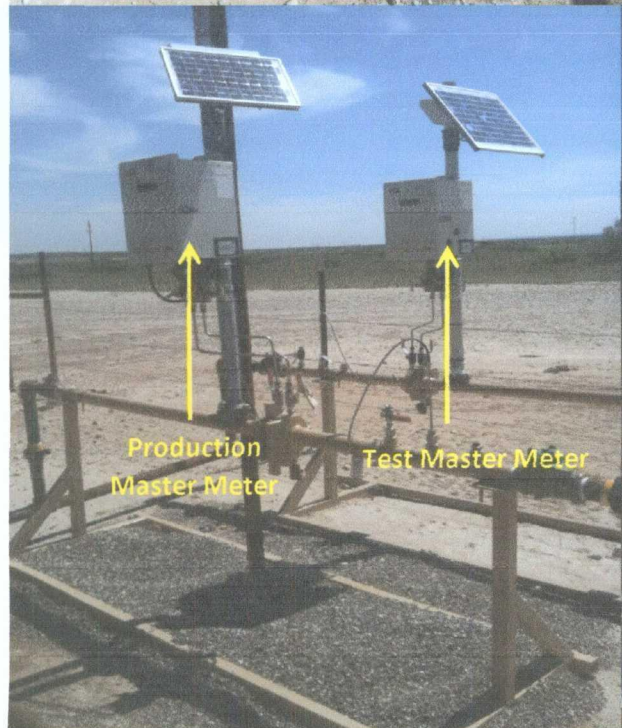
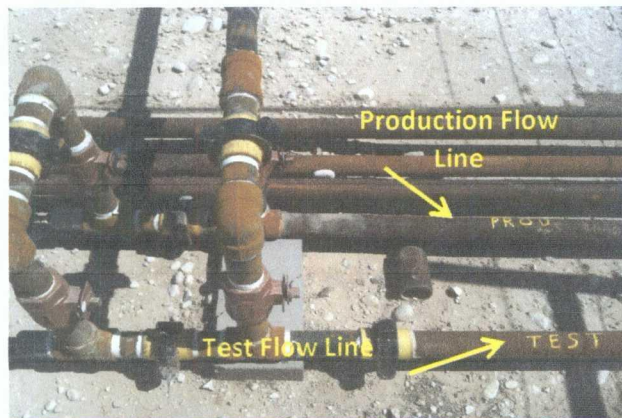




Wyatt Draw 17 K # 1 (Location/Battery) & Wyatt Draw 18/19 LD # 1H (Battery)









## Testing Procedure

This production facility is equipped with a testing header. At the header produced fluids (oil, water, and gas) enter the production facility. (Header is seen in picture #1).

At the header produced fluids may be sent to the testing vessel or the production vessel. Only one well will be sent to the testing vessel at a given time. The other wells that flow to this battery will be sent to the production vessel. The testing vessel is a 3 phase separator (seen in picture # 2) that will meter all phases prior to it commingling with other producing wells. The oil will flow thru the oil dump and pass thru an oil meter and be recorded. The water will pass thru the water dump and thru a water meter and be recorded. The gas will flow out the top of the separator and then thru a gas test meter and then be commingled with gas from the other wells at the production meter. Once the fluids leave the 3 phase separator and pass thru the meters the volume of oil, water, and gas has been determined.

All wells will be tested for a period of no less than 3 days per month to achieve the most accurate test information. In this case where there are only 2 wells being tested at this battery so each well will have approximately 15 – (24 hr well test) each month. Well test information is recorded in our auditable production system by the name of eVIN. Wells will be rotated in test and then into the production separators throughout there producing lives.

Allocation of oil, water, and gas production in a testing facility is very simple. At the end of the month the battery made a given amount of oil, water, and gas and all wells that flow to that battery have been tested. The well test will be used to determine each wells contribution to the entire batteries production and from that each well will get its percent of oil, water, and gas produced.
