Mr. Stogner,

Sorry to take up any of your time, but I have interesting situation this just arose. I received an e-mail from Bryan Arrant from the OCD in Artesia requesting a NSL approval for a well that has already been completed and put on line. All forms have been completed and approved as well as being issued an API# with no stipulations.

The South Four Mile Draw B Fed Com #8 (not 8y) was drilled at 704' FSL & 2112' FEL in Sec 22, T6S, R22E in Chaves County in 1998 without a NSL approval. The rig collapsed on the location, so we put a dry hole marker. We decided that the location was still good and moved the well bore over 17 ft, at 708' FSL & 2129' FEL, filed APD with all approvals and drilled in Sept 2003 and completed this well in October 2003 and put it on line. So having said that, is it my understanding that I need to go ahead and file for a NSL on our new well South Four Mile Draw B Fed Com #8Y as if it had not been drilled yet, even though we have already completed and put on line?

Re: *Your recent administrative application seeking an exception to Rule 4 (unorthodox infill gas well location) for McKay Oil Corporation's existing South Four Mile Draw "B" Federal Com. Well No. 8-Y (API No. 30-005-63639), located 708 feet from the South line and 2129 feet from the East line (Unit O) Section 22, Township 6 South, Range 22 East, NMPM, Chaves County, New Mexico.*

Dear Ms. McKay:

My preliminary review indicates your application may be incomplete with respect to notice. Please refer to Division Rule 1207.A (2) (a) which reads:

“(2) Unorthodox Well Locations: [1-1-87...2-1-96; Rn, 19 NMAC 15.N.1207.A. (5), 7-15-99; A, 7-15-99]

(a) Definition: “Affected persons” are the following persons owning interests in the adjoining spacing units:

- (i) the Division-designated operator;
- (ii) in the absence of an operator, any lessee whose interest is evidenced by a written document of conveyance either of record or known to the applicant as of the date the application is filed; and
- (iii) in the absence of an operator or lessee, any mineral interest owner whose interest is evidenced by a written document of conveyance either of record or known to the applicant as of the date the application was filed.

In the event the operator of the proposed unorthodox well is also the operator of an existing adjoining spacing unit and ownership is not common between the adjoining spacing unit and the spacing unit containing the proposed unorthodox well, then “affected persons” include all working interest owners in that spacing unit. [1-1-87...2-1-96; N, 7-15-99]”

Since McKay is the operator of the effected 160-acre Abo gas spacing unit, the SW/4 of

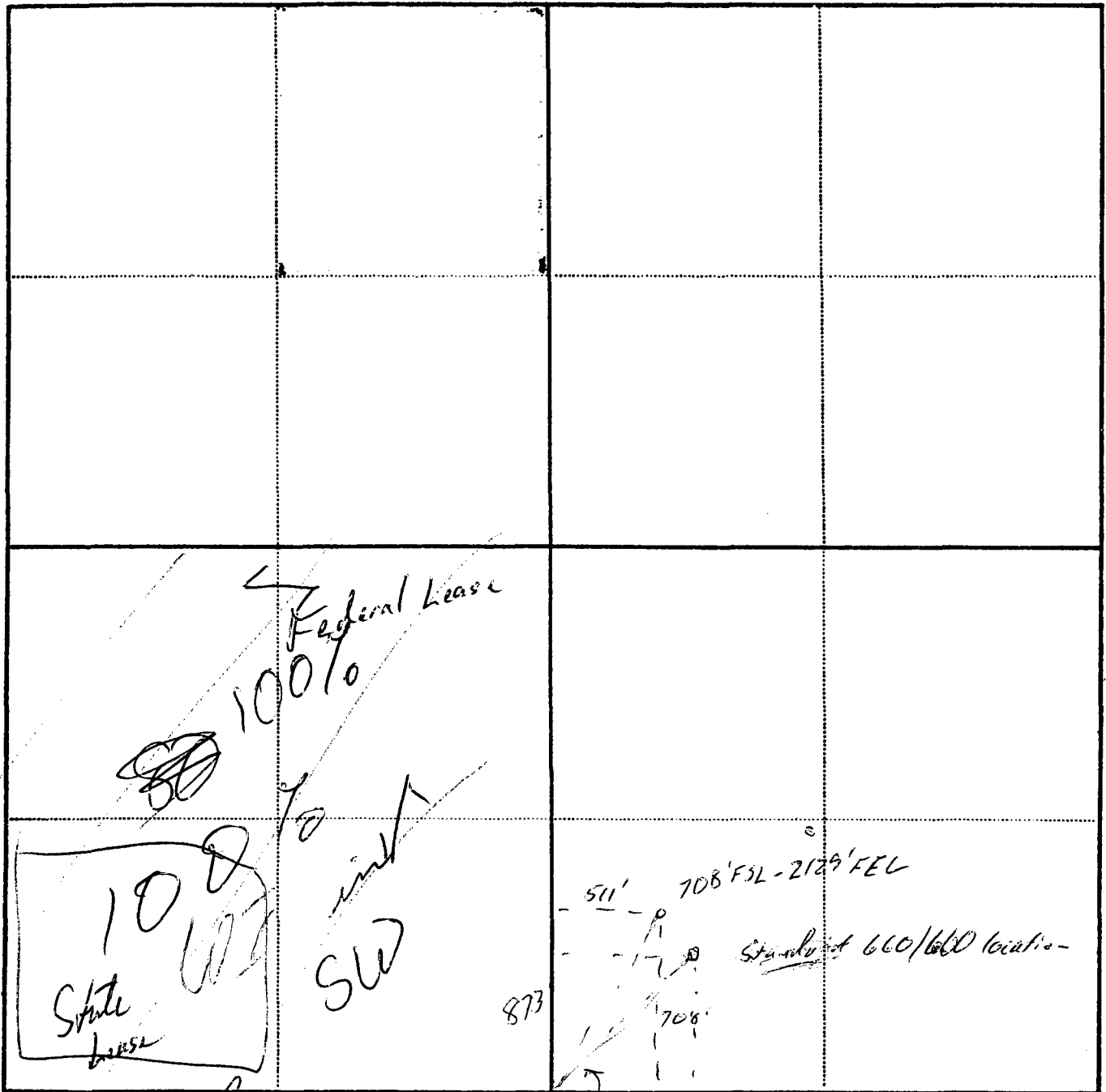
