Dear Mr. Stone:

Nearburg Producing Company hereby requests administrative approval for Off Lease Gas Measurement and Surface Commingling of the production from the wells listed on Attachment I. The sales meter for off lease measurement and surface commingling is located in Section 13, T21S, R25E, Eddy County, New Mexico. See Attachment II showing each well location.

All production will be individually metered on each well with a check meter. All meters will be calibrated on a regular basis.

We recently purchased the gas sales line from Duke Energy Field Service. The gas sales meter for the three commingled wells resides at the end of the gas sales line in Section 13, T21S, R25E, Eddy County, New Mexico. We are applying for the off lease gas sales measurement and surface commingling due to the gas sales line purchase.

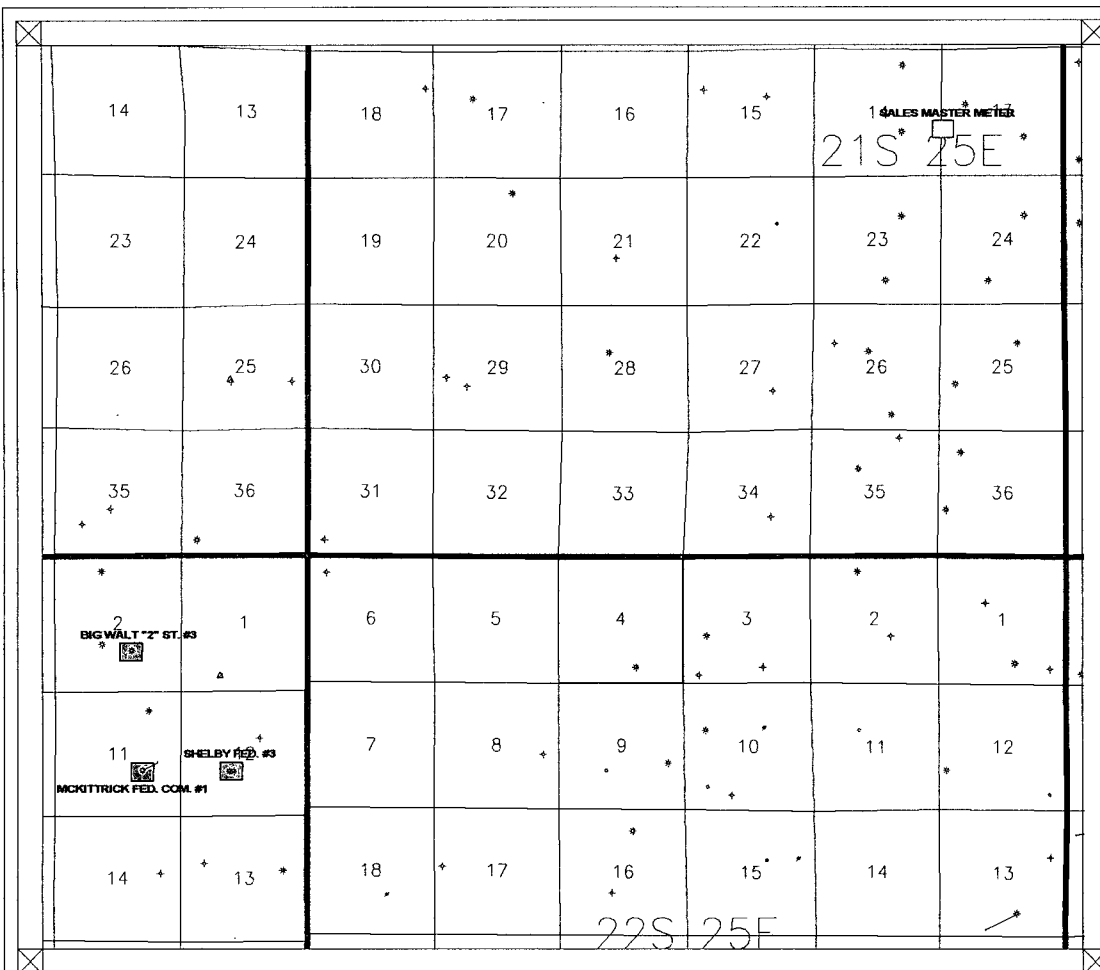
