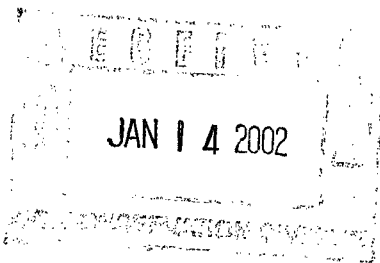

RE: Pool Commingling Application

Gentlemen:

Premier Oil and Gas, Inc. respectfully requests administrative approval to commingling hydrocarbon production from the Grayburg Jackson, Seven Rivers, Queen, Grayburg, San Andres pool with the Loco Hills, Paddock pool. Approval is being sought due to the need to remove the deteriorating Dale H. Parke "D" tank battery. The existing battery has forced Premier to stake a proposed Paddock test at an unorthodox location. Once approval is granted and tank battery removed, Premier can re-stake the proposed Paddock location so as not to affect offset operators. The Dale H. Parke "D" lease has only two Grayburg Jackson producers. They are the Dale H. Parke "D" No. 1 located at 1650' FSL and 330' FEL, and the Dale H. Parke "D" No. 2 located at 1650' FSL and 330' FEL. Both in Section 15 of Township 17 South, Range 30 East. Rebuilding the tank battery would be uneconomical due to the minimal production from these two wells.

In August 2001, Premier was granted approval to commingling Loco Hills Paddock production from the Dale H. Parke "D" lease with the Dale H. Parke "C" lease. Approval was granted by Commingling Order CTB-517. Therefore, the facilities needed are currently in use. Upon approval of the requested pool commingling, Premier will dismantle the existing Dale H. Parke tank battery and extend the flow lines from the No. 1 and No. 2 wells to the Dale H. Parke "C" tank battery. It is at this point that the two pools will be commingled.

Premier believes that no valve will be lost by commingling the pools. While a difference in overriding royalty interest exists, working interests are identical. Production will be allocated back to the separate pools by monthly tests. The following table compares the two pools:

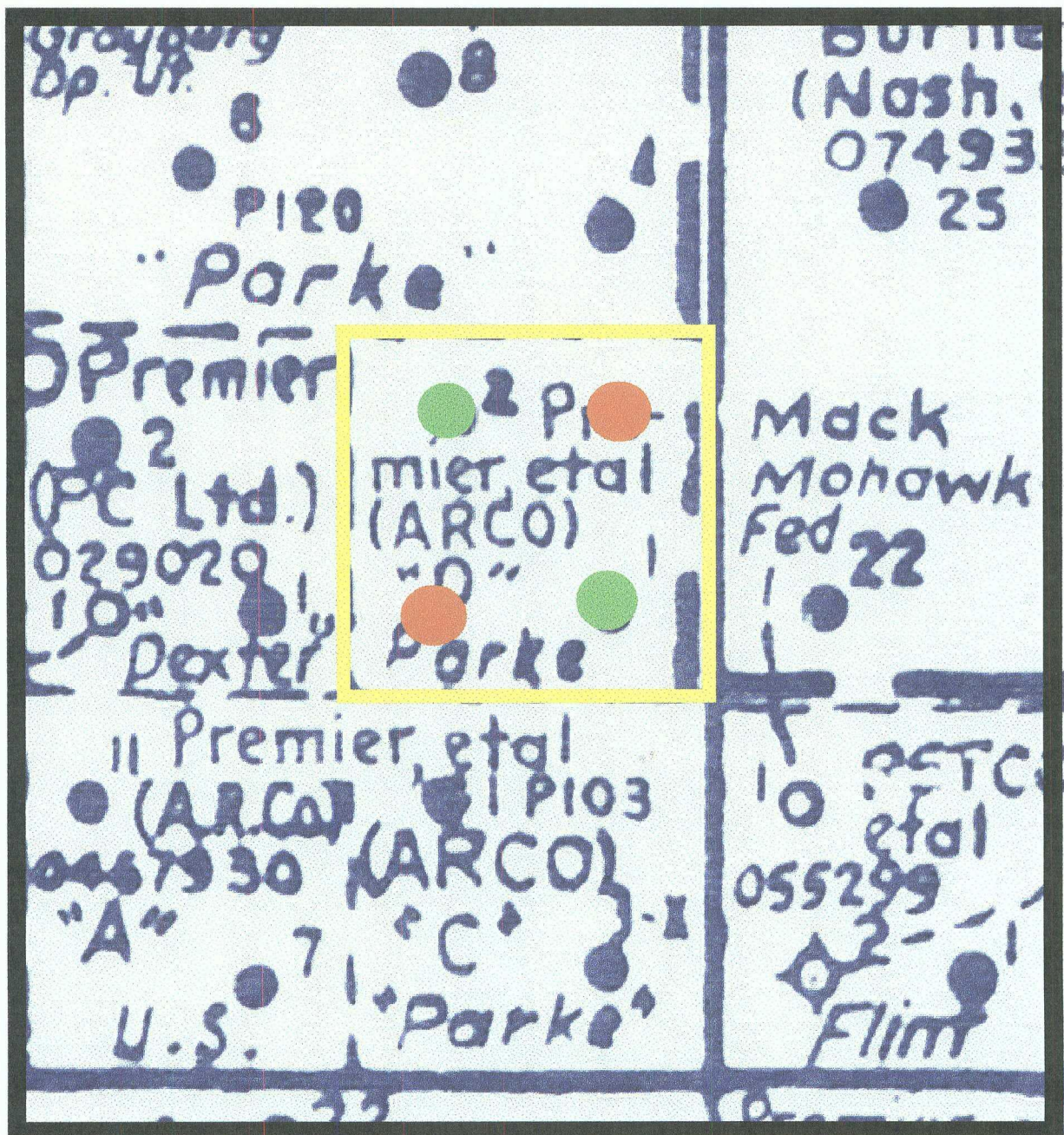

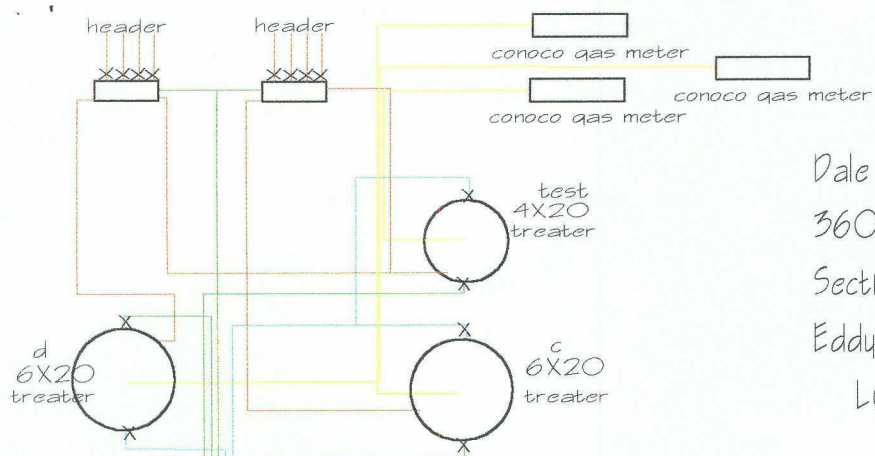

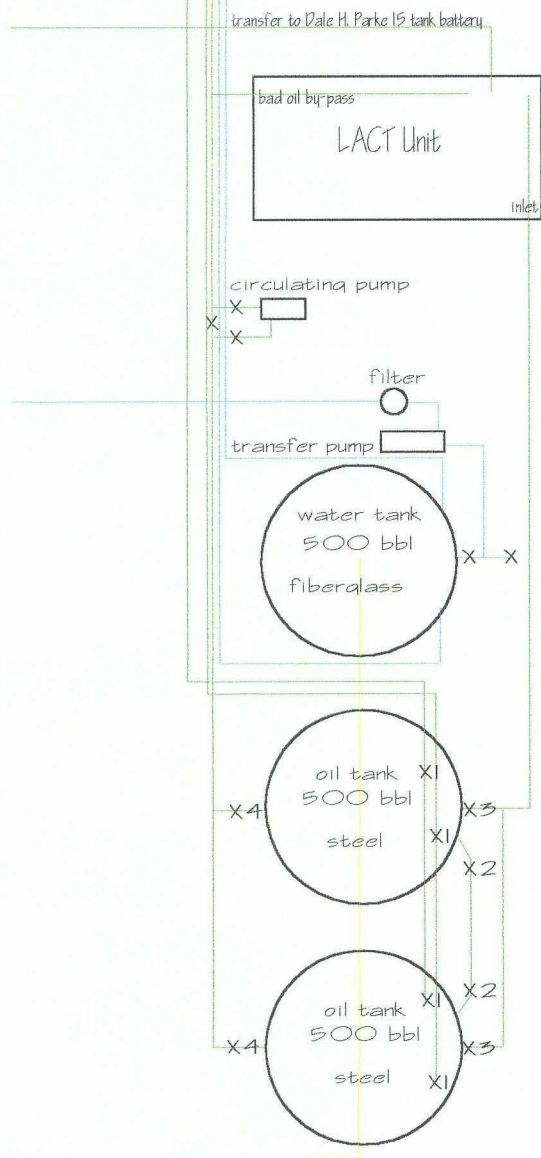
