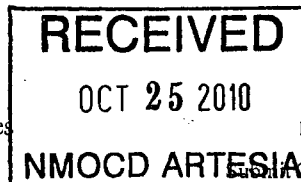




1/4" nipple broke on top of discharge assembly on centrifugal pump. The nipple has been replaced with heavier grade to prevent recurrence.					
Describe Area Affected and Cleanup Action Taken.*					
Initially 20bbls of produced water was released inside the facility which is lined with a 40 mil liner. All standing fluid was contained inside the facility firewalls. We were able to recover 19bbls with a vacuum truck. The spill measured an area of 45' x 165' inside the dike walls of the lined facility. There was also a light overspray to the west of the Battery measuring an area of 10' x 40. The oversprayed area will be monitored in the spring. We will follow up with a C-141 Final Report.
