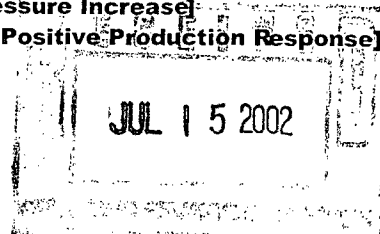

ChevronTexaco Exploration & Production Company, formerly Chevron U.S.A. Production Company, is requesting NMOCD approval to Pool (Surface) Commingle the oil, and gas production from the Baxter Culp 31 # 5, with oil and gas production from the Love 32 # 3.

ChevronTexaco, Inc., gives notice of intent to Pool (Surface) Lease Commingle the

BAXTER CULP 31 # 5 (330' FSL & 330' FEL, S-31-T19S-R37E), and
MAY LOVE 32 # 3 (330' FSL & 2310' FEL, S-32-T19S-R37E),

into the Love 32 Battery. The Baxter Culp 31 # 5 currently produces from the Blinberry Oil pool # 6660 and the Love 32 # 3 is currently producing in the Monument-Tubb pool # 47090. The gravity of the oil produced from both the Baxter Culp 31 # 5 and the Love 32 # 3 is 34.8° API @ 60 degrees, and it is anticipated that the oil gravity will remain the same.

ChevronTexaco Exploration & Production Company is the operator of these wells with a 100% ownership.

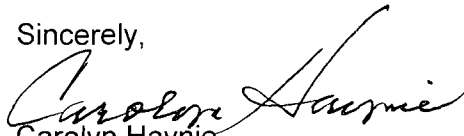

Gas, and oil, production will be allocated to each of these wells with the use of a metering separator located at the Love 32 Commingled Battery and will be installed in accordance with applicable provisions of the NMOCD's "Manual for the Installation and Operation of

Commingling Facilities. Commingling will not reduce the actual commercial value of gas or oil sold from each lease. Permission to commingle the wells would eliminate the need for separate production facilities at the Baxter Culp 31 and Love 32, resulting in substantially lower operating costs to ChevronTexaco and will extend the economic life of the wells.

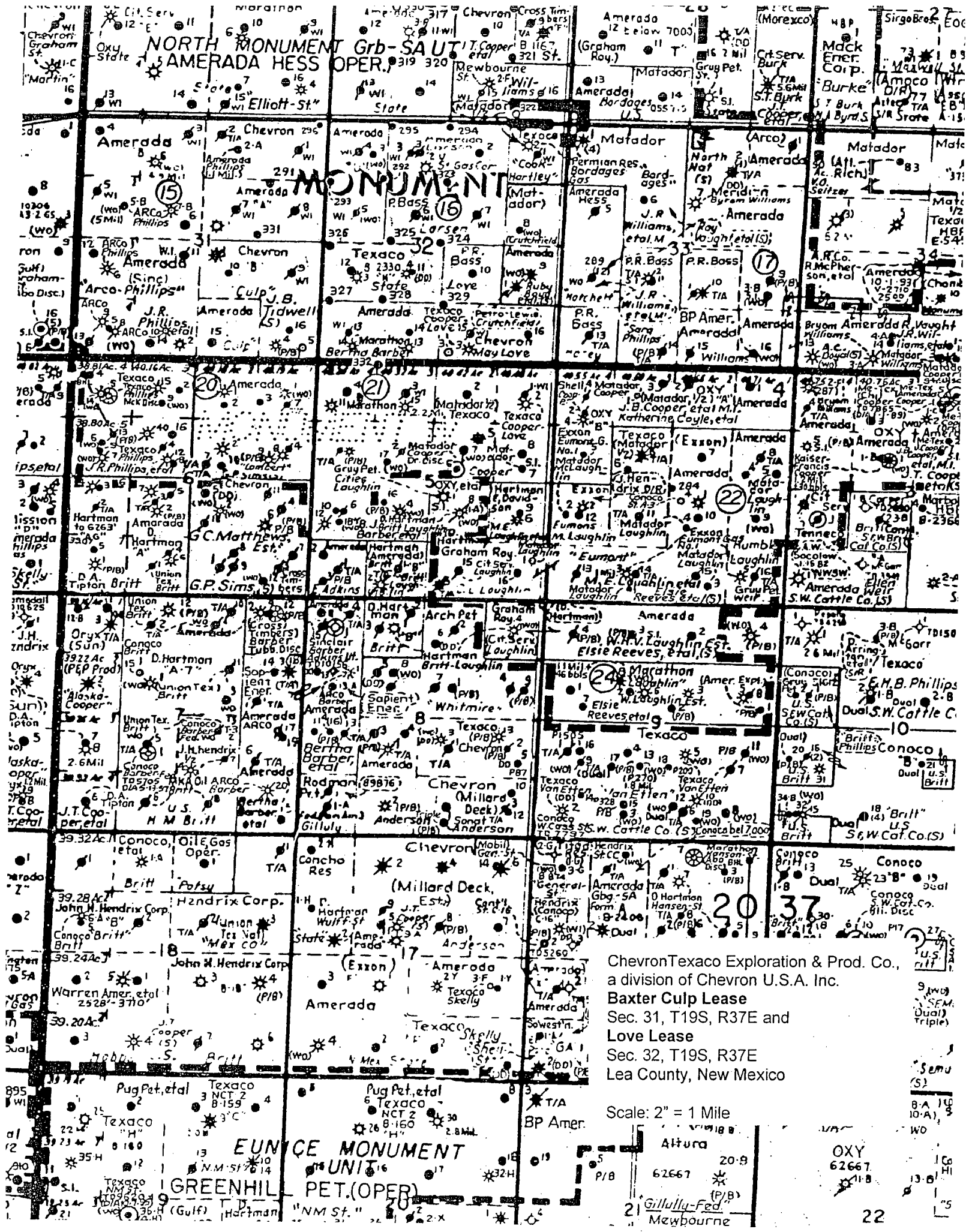
