

Describe Cause of Problem and Remedial Action Taken.*

During a pipe replacement at Jal Station, a motor valve inadvertently opened releasing approximately 25 bbls of oil into an open ditch line. A vacuum truck was utilized to recover the oil from the ditch line.

Describe Area Affected and Cleanup Action Taken.*

Released crude oil pooled in an open ditch line on the south side of the valve and was recovered with a vacuum truck. Impacted area will be remediated per applicable guidelines.
