Enclosed please find a Form C-141. Final Report for the above captioned site regarding the release on February 1, 2010 (126 B/C released with 0 B/C recovered). A C-141 Initial Report was submitted to your office on 2/11/2010. Initial samples were taken on 2/9/2010 and were above limits (TPH <1000 ppm & BTEX <50 PPM) for the site ranking of 10. The impacted soils were excavated to a depth of three (3) feet and taken to an OCD approved facility. Vertical and horizontal delineation samples were taken on 5/4/2010 & 5/12/2010 and sent to an OCD approved laboratory and were still above limits (TPH <1000 ppm & BTEX <50 PPM) for the site ranking of 10. On August 6, 2010 Yates requested Safety and Environmental Solutions, Inc. to measure the water depth of the well located in Section 7, T20S-R29E, depth of the water measured at 65' below ground surface. Based on that information the site ranking remained at a ten (10) and the impacted soils were excavated (9/27/2010 - 10/1/2010) to a depth of twelve (12) feet and taken to an OCD approved facility (total excavation area is approximately 45' wide X 75' long X 12' deep). Vertical and horizontal delineation samples were taken on 11/2/2010 and sent to an OCD approved laboratory and were below RRAL's for the site ranking of 10. Enclosed are the analytical reports and sample diagram. There is currently an open excavation, it is fenced but still poses a threat to livestock, human health, Yates Petroleum Corporation requests closure based on the impacted soils excavated/removed, analytical results and current open excavation risks.


