

Describe Cause of Problem and Remedial Action Taken.\*

The float inside the oil tank blocked the equalizer line causing the tank to overflow. The float has been inspected and the tank has been returned to service.

Describe Area Affected and Cleanup Action Taken.\*

Initially 24bbbls of oil was released from the tank and we were able to recover 23bbbls with a vacuum truck. All fluid was contained inside the facility firewall, which is lined with a 40 mil plastic liner. Any contaminated gravel will be removed and we will replace with clean gravel as necessary. We will follow up with a C-141 Final Report.
