Gentlemen:

Energen Resources Corporation (Energen) hereby requests Administrative Approval for an Unorthodox Location of its Jicarilla 96 # 600H Mancos formation well under the provisions of New Mexico Oil Conservation Division, Basin Mancos gas Pool Rules.

This well is proposed to enter Section 2 at a point 200' FWL and continue horizontally to a point 200' FEL of Section 2-T26N-R3W, Rio Arriba County, New Mexico. The dedicated spacing unit for this well is the N/2 of Section 2-T26N-R3W.

This well is located closer than 660' from the eastern and western spacing unit boundaries by 460' in each direction. This location is being drilled as a horizontal well bore and is situated so that the longest lateral can be accessed. This additional length is required to provide for the potential for the production of the most reserves and the best possible economics for this well.

Energen Resources Corporation is the operator of the affected spacing units on both the east and west boundaries. There are no working interest owners to notify as Energen is 100% working interest owner in the affected offsetting sections. Attached are a well location plat showing dedicated acreage (C102), a memorandum from the Energen geologist who works this area and a plat showing the affected spacing unit.

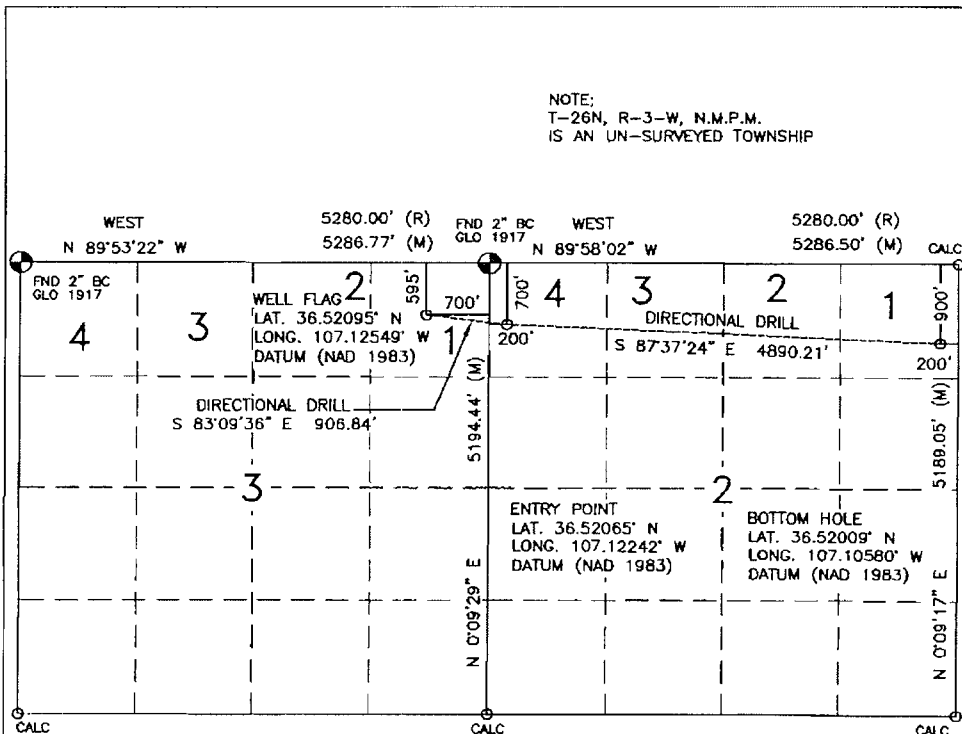

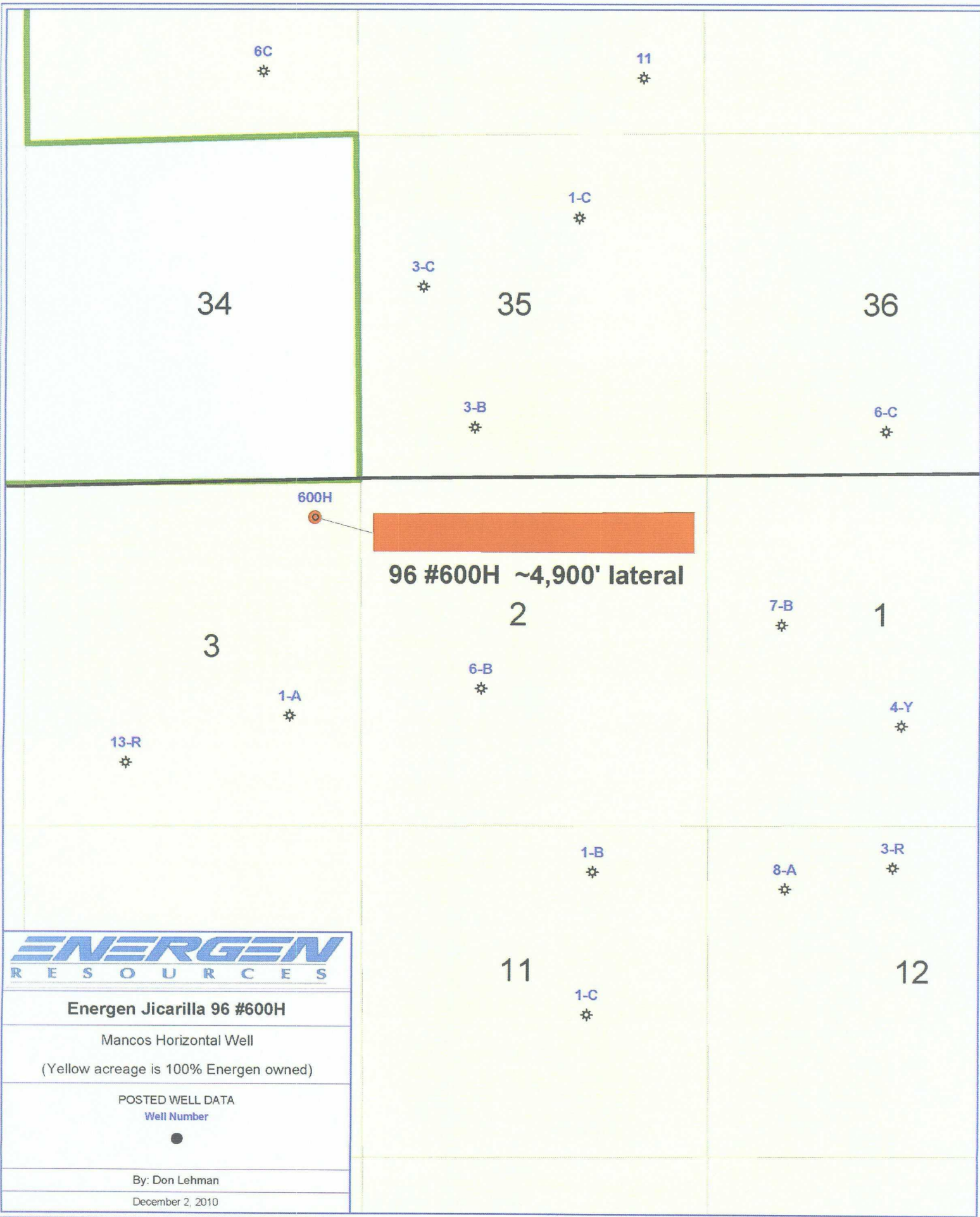

Reduced set-backs of 200 feet versus the current legal 660' are requested for this well in order to gain optimal production from the Mancos/Gallup reservoir. Horizontal drilling has proved that maximum lateral length is the most efficient method in draining a reservoir and thus the request for 200' set-backs. Offset acreage to the east and west of the proposed lateral and 200' set-backs is 100% owned by Energen Resources.
