

Pursuant to NMAC 19.15.15.13, Mewbourne Oil Company applies for approval of an unorthodox oil well location for the following well:

Well:Zebra 16 State Com. Well No. 1Surface location:385 feet FSL & 330 feet FWLBottom hole location:330 feet FNL & 385 feet FWL

Well unit (project area): W½W½ of Section 16, Township 17 South, Range 35 East,

N.M.P.M., Lea County, New Mexico

The well will be drilled to a depth sufficient to test the North Vacuum-Abo Pool. Under Order No. R-2421, the pool is spaced on 80 acres, with the <u>initial</u> well to be located within 200 feet of the center of either the NW¼ or SE¼ of the quarter section (there are no other well location requirements). A Form C-102 is attached as **Exhibit A**.

The unorthodox surface location was selected because (i) it is closest to well control, and (ii) it will increase the productive length of the wellbore.


