The New Mexico Oil Conservation Division (OCD) has received the Rice Operating Company's (ROC) report of the soil closure of the above-referenced site (dated August 1, 2011). The above-referenced report, submitted in fulfillment of 19.15.29 NMAC (Part 29, formally, Rule 116), indicates that Rice Operating Company (ROC) has partially met the requirements of 19.15.29 NMAC for this site. Therefore, the OCD hereby conditionally approves the soil closure for the BD Jct P-30 Site and no further soil remediation is required for this site.

The BD Jct P-30 Site is still active under Remediation Plan, 1R426-124, and groundwater monitoring (if necessary), groundwater contamination delineation (if necessary), and groundwater remediation must continue at the BD Jct P-30 Site.

RICE Operating Company (ROC) respectfully requests an additional 60 days to complete and finalize the BD Jct. P-30 (1R426-124) corrective actions approved by NMOCD on February 1, 2011.
