

Describe Cause of Problem and Remedial Action Taken.*

4inch 300 threaded check valve on load line was left partially open. The valve has been closed.

Describe Area Affected and Cleanup Action Taken.*

Initially 15bbbls was released from the valve at the load line and we were unable to recover any fluid from the release. The spill area measured 3' x 100' in front of the load line on the location; 2' x 200' ran off of the location into the pasture and accumulated into a 20' x 20' area. Tetra Tech will sample the spill site area to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD / BLM for approval prior to any significant remediation work.
