Pursuant to Division Rule 19.15.15.13, Apache Corporation ("Apache") respectfully requests administrative approval of an unorthodox oil and gas well location and simultaneous dedication for its proposed Lou Worthan Well No. 30. This well will be drilled as a development gas well in the Blinebry Oil & Gas Pool (Prorated Gas-72480), a development oil well in the Tubb Oil & Gas Pool (Oil-60240) and a development well in the Drinkard Pool (Oil-19190).

In the Blinebry Oil and Gas Pool the proposed Lou Worthan No. 30 and the existing Lou Worthan No. 5 (API No. 30-025-10214) located 660 feet from the North line and 1980 feet from the West line of Section 11) will be simultaneously dedicated to an existing 40-acre non-standard gas spacing and proration unit comprising the NE/4 NW/4 of Section 11 (approved by Order No. NSP-1937-A npt). Consequently, Apache seeks approval of an unothodox gas well location and simultaneous dedication for this well in the Blinebry Oil & Gas Pool. (Note: NSP-1937-A npt established eight 40-acre non-standard gas spacing and proration units in the Blinebry and Tubb Oil & Gas Pools within the N/2 of Section 11.)

In the Tubb Oil & Gas Pool the proposed Lou Worthan No. 30 will be drilled as a development oil well and dedicated to a standard 40-acre oil spacing and proration unit comprising the NE/4 NW/4 of Section 11. Consequently, Apache seeks approval of an unorthodox oil well location for this well in the Tubb Oil & Gas Pool.

In the Drinkard Pool, the proposed Lou Worthan No. 30 will be drilled as a development oil well and dedicated to an existing 40-acre oil spacing and proration unit comprising the NE/4 NW/4 of Section 11. This unit is currently dedicated to the Apache Lou Worthan Well No. 13 (API No. 30-025-24943) located at a standard location 330 feet from the North line and 2080 feet from the West line.) Consequently, Apache seeks approval of an unorthodox oil well location for this well in the Drinkard Pool.

The Blinebry and Tubb Oil & Gas Pools are currently governed by the General Rules and Regulations for the Prorated Gas Pools of New Mexico/Special Rules and Regulations for the Blinebry and Tubb Oil & Gas Pools as established by Order No. R-8170, as amended. These rules require standard 160-acre gas spacing and proration units and 40-acre oil spacing and proration units. Setback requirements for gas wells to which more than 40 acres is dedicated are 660 feet to the outer boundary of the spacing unit or of the quarter section, and 330 feet to any governmental quarter-quarter section. The setback requirement for oil wells and gas wells to which no more than 40 acres is dedicated is 330 feet to the outer boundary of the spacing unit.

The Drinkard Pool is subject to Division Rule 19.19.15.9.

The Lou Worthan No. 30 is being drilled as an infill location between existing Blinebry, Tubb and Drinkard producers. A well at this location should recover additional oil and gas reserves from the target reservoirs that will otherwise not be drained by the existing wells, thereby preventing waste.

In support of the application, the following tables show the offset wells, drainage areas, estimated ultimate oil and gas recoveries, cumulative oil and gas production (as of 10/2010) and current daily oil and gas producing rates. (Note: drainage areas were calculated from SophiH taken off contoured isopach maps or from log calculations.)

Utilizing the average offset drainage areas and SophiH and applying it to the proposed location for the Lou Worthan No. 30 results in an estimated recovery of 33 MBO and 3,300 MMCF of gas from the Blinebry, Tubb and Drinkard reservoirs.

The affected offset acreage with regards to the unorthodox location in the Blinebry Oil & Gas, Tubb Oil & Gas and Drinkard Pools is the NW/4 NW/4 of Section 11. This affected acreage is operated by Apache and is contained within the commonly-owned Lou Worthan lease. The Lou Worthan Lease encompasses the entire N/2 of Section 11.


