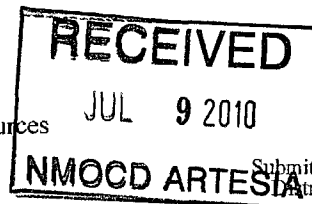

Describe Cause of Problem and Remedial Action Taken.*

A hole in nipple of holding tank attached to flow line was source of oil spill. The spill was contained within the tank battery dike area. An estimated 40bbbls was spilled and 20bbbls was recovered and pumped back into storage tank. The faulty nipple was replaced immediately. The spill area within the tank battery dike is 12yds X 25yds. This tank battery is for the Robinson Federal #2 API #3001524134. Remediation action taken was to pump 20bbbls of freestanding oil back into tank. No further remedial action has been taken yet. A sampling investigation will be conducted to delineate the extent of contamination. A sampling report will be submitted to OCD with a remediation plan to be implemented upon NMOCD approval.

Describe Area Affected and Cleanup Action Taken.*

This oil spill was completely contained within the bermed area of tank battery facility. No other area was impacted. The spill area within the tank battery dike is 12yds X 25yds. Recommended remediation is to conduct "dig & haul" operation with lab analysis. Contaminated soil will be removed to a locally approved disposal site and back filled with clay based impermeable soil. A closing report will then be submitted to OCD.

I hereby certify that the information given above is true and complete to the best of my knowledge and understand that pursuant to NMOCD rules and regulations all operators are required to report and/or file certain release notifications and perform corrective actions for releases which may endanger public health or the environment.
