Sometime during the night of 7/29/09 and 7/30/09 an unknown trucking company backed to the west edge of location and dumped an estimated amount of Produce water and Oil mix into the pasture covering an area approximately 200' long and 30' wide(average). The spill looked to be mostly produce water with a skim of oil. Soil samples were gathered and analyzed. A work plan was agreed upon by NMOCD Representative. Mike Bratcher, to excavate the area to a 1' depth and backfill with clean like soils. This site was remediated to this agreed work plan and closed.

Describe Area Affected and Cleanup Action Taken.*

Remediated to NMOCD Requirements.
