The water transfer pump malfunctioned; it has since been repaired and put back into service.

Describe Area Affected and Cleanup Action Taken.*

Initially 23bbbls of produced fluid was released and we were able to recover 21bbbls with a vacuum truck. All fluid was completely contained inside the facility walls. The spill area measured 5' x 50' inside the bermed area by the tanks. The spill area has been scraped and the contaminated material has been disposed of appropriately. Tetra Tech will sample the spill site area to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation work.
