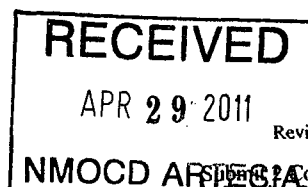



An oil tank at the facility ran over due to an increased amount of production overnight. The production volumes have been cut back to eliminate reoccurrence in the future.					
Describe Area Affected and Cleanup Action Taken.*					
Initially 60bbls were released from the oil tank and we were able to recover 58bbls with a vacuum truck. The entire release was completely contained inside the facility walls of the tank battery. This facility is lined with a 40mil liner. Any contaminated gravel will be removed and disposed of appropriately. Clean gravel will be added as necessary. This facility will be returned to its prior condition.

Mr. Bratcher,

Please see the detailed description below of an immediately reportable release.

On 4-19-11 the oil tanks ran over at the Blackhawk 11 Federal #1. This was caused by an unexpected rush of oil production in the tanks. 60bbls of produced oil was released into the dike, which is lined with 40 mil plastic. 58bbls were recovered. The well was choked back to slow down production and returned to service. We will follow up with a C-141 Initial Report.
