By Order No. NSL-5397 dated June 9, 2006, the Division authorized CDX Rio, L.L.C. to drill the Jicarilla A Wells No. 8M and 8N at unorthodox infill gas well locations in both the Blanco-Mesaverde (72319) and Basin-Dakota (71599) Gas Pools 750 feet from the North line and 2240 feet from the East line (Unit B), and 1420 feet from the South line and 2475 feet from the East line (Unit J), respectively, both in Section 17, Township 26 North, Range 5 West, NMPM, Rio Arriba County, New Mexico. The E/2 of Section 24 was dedicated to both wells in the Blanco-Mesaverde and Basin-Dakota Gas Pools.

Enervest Operating, L.L.C. ("Enervest"), the successor operator of these wells, hereby requests an amendment to Order No. NSL-5397 to authorize non-standard location approval for both wells in the Tapacito-Gallup Associated Pool (58090). The Tapacito-Gallup Associated Pool is currently governed by the "Special Rules and Regulations for the Tapacito-Gallup Associated Pool/General Rules and Regulations for Associated Oil and Gas Pools in Northwest and Southeast New Mexico", as established by Division Order No. R-5353, as amended. These rules provide that:

- 1) A standard oil proration unit shall be 80 acres. A standard gas proration unit shall be 320 acres;
- 2) Wells shall be located no closer than 790 feet to any quarter section line nor closer than 330 feet to any quarter-quarter section line or subdivision inner boundary;
- 3) A well shall be classified as a gas well if it has a gas-liquid ratio of 30,000 or more cubic feet of gas per barrel of liquid hydrocarbons. If the gas-liquid ratio is less than 30,000:1, it shall be classified as an oil well.

Enervest has not yet drilled the subject wells, but recent activity in this area indicates that the Gallup interval may be commercially productive. The wells are proposed to be completed as downhole commingled completions in the Blanco-Mesaverde, Basin-Dakota and Tapacito-Gallup Associated Pools. The Aztec District Office of the Division has already approved the downhole commingling of the Basin-Dakota and Blanco-Mesaverde Gas Pools within the subject wells, however, due to the addition of the Gallup interval, Enervest is preparing amended downhole commingling applications to add the Tapacito Gallup-Associated Pool.

In the event the Jicarilla A No. 8M is determined to be an oil well, the W/2 NE/4 of Section 17 will be dedicated to the well forming a standard 80-acre oil spacing and proration unit in the Tapacito-Gallup Associated Pool.

In the event the Jicarilla A No. 8N is determined to be an oil well, the W/2 SE/4 of Section 17 will be dedicated to the well forming a standard 80-acre oil spacing and proration unit in the Tapacito-Gallup Associated Pool.

In the event one or both wells are determined to be gas wells, the well(s) will be dedicated to an existing 320-acre gas spacing and proration unit in the Tapacito-Gallup Associated Pool comprising the E/2 of Section 17. This unit is currently dedicated to the Enervest Jicarilla A Well No. 8 (API No. 30-039-08163) located 2365 feet from the North line and 790 feet from the East line (Unit H) of Section 17.

Under the scenario in which either or both the Jicarilla A Wells No. 8M and 8N are classified as oil wells, Enervest will file an application to create a non-standard gas spacing and proration unit that will include acreage in the E/2 of Section 17 not dedicated to an 80-acre oil unit.

Pursuant to the general rules for the associated pools, Enervest is required to provide notice of this application to "all operators of proration or spacing units offsetting the unit for which the unorthodox location is sought". A search of Division records shows that the following-described wells are producing as gas or oil wells from the Gallup formation in offset units:

Section 8, T-26N, R-5W: **Noble Energy, Inc.:**

Section 16, T-26N, R-5W: **Enervest Operating, LLC:**

Section 21, T-26N, R-5W: **Enervest Operating, LLC:**
 Jicarilla B No. 4 (Unit H) E/2 Dedication
 Jicarilla B No. 5E (Unit E) W/2 Dedication

Section 20, T-26N, R-5W: **Enervest Operating, LLC:**
 Jicarilla A No. 5 (Unit G) E/2 Dedication

As indicated on the attached plat, Enervest will provide notice of this application to all operators of proration or spacing units offsetting the proposed Jicarilla A Wells No. 8M & 8N.

These offset operators include Noble Energy, Inc. and Energen Resources Corporation. Please note that Enervest also operates offset acreage in the W/2 of Section 17 and all of Sections 16, 20 and 21, T-26N, R-5W, and that the interest ownership in this offset acreage and in the E/2 of Section 17 is common throughout. Also please note that Enervest also operates offset acreage in Section 9, T-26N, R-5W. Since the working interest ownership between the E/2 of Section 17 and Section 9 is slightly different, Enervest is providing notice of this application to the Jicarilla Apache Nation, the only other working interest owner in Section 9.

Attached is a plat showing the proposed spacing unit, unorthodox well locations and adjoining spacing units and wells.

Approval of the requested amendment will provide Enervest the opportunity to recover Gallup reserves underlying the W/2 NE/4, W/2 SE/4 or the E/2 of Section 17, thereby preventing waste, and will not violate correlative rights.

I am working with Enervest and I put together the subject application.

Please note that the Jicarilla A No. 8M is located in Unit B of Section 17. Since the well encroaches to the north, we have notified Energen and Noble Energy, the leasehold owners and/or operators in the affected offset acreage in Section 8.
