Pursuant to Division Rule 19.15.15.13, Apache Corporation ("Apache") respectfully requests administrative approval of an unorthodox oil well location for its proposed D State No. 59. This well will be drilled as a development oil well in the Artesia Glorieta-Yeso Pool (96830).

The proposed D State No. 59 will be dedicated to an existing standard 40-acre oil spacing and proration unit in the Artesia Glorieta-Yeso Pool comprising the SE/4 SE/4 of Section 26. This unit is currently dedicated to the existing Apache D State No. 2 (API No. 30-015-31421) located 990 feet from the South line and 430 feet from the East line, and the proposed D State No. 51 (API No. 30-015-38585) to be drilled 900 feet from the South line and 990 feet from the East line.

The Artesia Glorieta-Yeso Pool is currently governed by Division Rule 19.19.15.9 which requires standard 40-acre oil spacing and proration units with wells to be located no closer than 330 feet to the outer boundary of the spacing unit.

The attached vicinity map shows that the proposed unorthodox well location is necessary in order to avoid an existing tank battery and overhead power lines.

The affected offset acreage includes the SW/4 SW/4 of Section 25, the NE/4 NE/4 of Section 35, and the NW/4 NW/4 of Section 36, all in Township 17 South, Range 28 East. All three of these affected tracts are existing 40-acre spacing units in the Artesia Glorieta-Yeso Pool, and all three are operated by Apache. Please note that the working interest ownership between the SE/4 SE/4 of Section 26 and the three affected offset

40-acre tracts is common. Consequently, notice of this application is not required to any party.

Attached is a Form C-102, vicinity map, and a map showing the affected offset acreage.

In summary, approval of the application will provide Apache Corporation the opportunity to recover additional oil and gas reserves from the Artesia Glorieta-Yeso Pool underlying the SE/4 SE/4 of Section 26 that may otherwise not be recovered by the existing or proposed producing wells, thereby preventing waste, and will not violate correlative rights.





Affected Offset Acreage


