Dear Mr. McKinney:

Reference is made to your application for an exception to Division Rule 12.9.A [19.15.12.9.A NMAC] to permit down hole commingling of production from the subject pools within the above-described wellbore.

It appearing that the subject well qualifies for approval for such exception pursuant to the provisions of Rule 12.11.A [19.15.12.11.A NMAC], and that reservoir damage or waste will not result from such down-hole commingling, and correlative rights will not be violated thereby, you are hereby authorized to commingle the production as described.

In accordance with Division Rule 12.11.A(6) [19.15.12.11.A(6) NMAC], the production attributed to any commingled pool within the well shall not exceed the allowable applicable to that pool.

Assignment of allowable and allocation of production from the well shall be as follows:


It is our understanding that the allocation percentages will be based on volumetric calculations, and will be reported to the Division's Santa Fe Office within 60 days after workover of this well is completed.

It is also understood that working, royalty and overriding royalty interests are not identical and all working, royalty and overriding royalty interests owners have been notified by certified mail. It is further understood that no BLM or State Land is involved in this application.

The operator shall notify the Division's Aztec district office upon implementation of commingling operations.

This administrative **order supersedes** Administrative Order Number DHC-4369 in its entirety.

Pursuant to Rule 12.11.B [19.15.12.11.B NMAC], the commingling authority granted herein may be rescinded by the Division Director if conservation is not being best served by such commingling.
