Greetings,

A NMOCD inspection of the above referenced well site on 5/4/2011 shows indications of one or more produced fluids releases having occurred at this well site. It appears a tank overflowed allowing fluids to run north and west across location. Tank battery and well head area show indications of multiple produced fluids releases. Berm around tank battery is poorly constructed and breached in several places. An area on south side of location shows signs of produced fluids having sprayed and flowed out into pasture area.

Submit a form C-141 for the release/releases that have occurred at this well site. Form/forms are to be submitted to the NMOCD District 2 office not later than 5/19/2011. A proposal for remediation is to be submitted to the NMOCD District 2 office not later than 6/19/2011. The proposal is to be based on contaminant delineation, site ranking and NMOCD Rules and Guidelines. Notify me 48 hours prior to obtaining samples where the analyses are to be submitted to the NMOCD.
