Dear Mr. Porter:

On November 6, 1959, completion was filed on the Wilson Oil Company State F #1, Unit P, Section 19-T21S-R35E. This completion is for an amount of 9 barrels oil and 10 barrels water per day pumping.

At present the crude oil from the eastern area of the Wilson pool is being trucked to receiving tanks on the Texas-New Mexico Pipe Line. The Texas-New Mexico Pipe Line Company is currently making a survey for the extension of their pipe line facilities into this area. This survey should be completed within the next six months.

In order to keep tank battery cost at a reasonable figure and to set permanent equipment at the most effective location, permission is requested for the Wilson Oil Company to commingle the oil from their #1 State F and their #1 State 19, in Units P and A respectively, of Section 19-T21S-R35E. These leases are both State leases and carry numbers E-3145 for #1 State 19 and E-5890 for #1 State F. Both leases are marginal with #1 State 19 having an allowable of 14 barrels and #1 State F having an allowable of 9 barrels.

It is proposed to transport the oil from both leases to receiving tank No. 28496 on the Texas-New Mexico line.

We would appreciate receiving your permission to commingle the oil on a temporary, emergency basis, for said six months period at your earliest convenience.
