Gentlemen:

We have raviewed your application to commingle production from the State "O" lease with the production from the State "Q", State "R" and State "S" leases. The state beneficiary under the State "O" Lease is the Miners Hospital. The beneficiary under the State "Q", State "R" and State "S" leases is Common Schools. Since there are two different beneficiaries involved, we can not approve your application. Rule 52, of the State Land Office Rules and Regulations states as follows:

"Commingling Prohibited-Different Beneficiary Institutions.

It is required that all production of oil and/or gas from lands belonging to different state beneficiaries shall be segregated. The commingling, confusion or the intercommunication of such production by the utilization of common tankage facilities, before marketing, with the production from any other institutional lands or any lands not belonging to the State of New Mexico is strictly prohibited."

Enclosed is a copy of our Rules and Regulations on Commingling of Oil and Gas on State owned lands.

In your letter your State "O" Lesse is described wrong, it should be the NE/4 and SE/4, SE/4NW/4, and Lots 3 and 4. Your No. 9 well is in the SW/4SW/4 and the well No. 10 is in the NW/4SW/4 of Section 31-T16S-R37E.

Gentlemen:

Skelly Oil Company herein makes application for approval to commingle similar crudes from a common reservoir into a central tank battery from the above mentioned leases. The State "Q" and "R" are presently being commingled under authority granted in 1960 by administrative order CTB No. 53.

In support of this application Skelly Oil Company states the following:

- 1. Permission is requested to commingle oil production from the Lovington Abo formation into a central tank battery. There are several reasons why we feel this request should be granted, among these are: (1) More efficient operations. (2) Will reduce manpower and equipment requirements. (3) Through reduction of expenditures, economic life of leases will be extended thereby increasing revenue to Skelly Oil Company and the State of New Mexico.
- 2. Plats are attached which indicate the following: location of leases, wells, present and proposed flow lines, location of stock tanks. All piping (both present and proposed) will be on the surface.
- 3. Following is a list of the involved leases arranged by their State Land Office lease number, their legal description; all

of these state leases concern a single royalty owner, that being the State of New Mexico and are all dedicated to a common beneficiary which is the New Mexico Common Schools.

- A. State "S" Lease No. B-7316. Applicants State "S" lease is a 40 acre tract confined by the SE/4 of the SE/4 of Section 35-T16S-R36E and has 1 Lovington Abo Well No. 2.
- B. State "R" Lease No. B-7766. Applicants State "R" lease is a 240 acre tract confined by the NW/4 and E/2 of the SW/4 of Section 36-T16S-R36E, which has 2 Lovington Abo Wells, Nos. 5 and 6. These 2 wells are currently being commingled with the 2 Lovington Abo wells located on the State "Q" lease.
- C. State "Q" Lease No. B-7845. Applicants State "Q" lease is an 80 acre tract confined by the S/2 of the SE/4, Section 36-T16S-R36E, which has 2 Lovington Abo Wells, Nos. 3 and 4. These two wells are currently being commingled with 2 Lovington Abo wells located on the State "R" lease.
- D. State "O" Lease No. B-7896. Applicants State "O" lease is a 459 acre tract confined by the NW/4 and SE/4, Section 31-T16S-R37E, which has 2 Lovington Abo Wells Nos. 9 and 10, which are located on an approximate 80 acre tract in the SW/4 of SW/4 of Section 31-T16S-R37E. We desire to commingle these 2 wells into common tankage with oil production from the above described leases.
- 4. All of the above described wells contained within the described leases produce from a common source of supply or reservoir, that being the Abo formation. The pool designation for this oil productive pay in this area is the "Lovington Abo Pool."
- 5. Due to the fact that similar crudes with similar gravities and characteristics and from a common reservoir are being commingled, there will be no significant increase or reduction in value of the commingled oil; however, there are economic benefits which will be realized by the State of New Mexico as a result of permitting Skelly Oil Company to commingle as proposed: Through a streamlining of our operation and improved efficiency, the economic life of these leases will be extended, less manpower, less equipment and facilities will increase the net value of a barrel of oil which in turn will allow for a longer economic life of the leases.
- 6. A schematic diagram of the proposed oil handling, storage, and sales facilities are attached.
- 7. All components which will be utilized in this system are commercially available.
- 8. The production of oil and gas from each state lease will be properly accounted for through use of a portable well tester and periodic

well testing as prescribed by the New Mexico Oil Conservation Commission. None of the wells which will be producing into the commingling system are top allowable.




