Phillips Petroleum Company herewith makes application for an exception to Rule 309a of the Rules and Regulations of the New Mexico Oil Conservation Commission and requests administrative approval to commingle the production of oil from two separate and contiguous oil and gas leases.

The following is a description of the subject leases:

Yates "A" Lease, W/2, SE/4, and SW/4, Section 29, T-21-S, R-35-E, Lea County, New Mexico.

Merchant "A" Lease, W/2, NE/4, Section 32, T-21-S, R-35-E, Lea County, New Mexico.

Attached is a plat of the above leases showing all offset operators.

In support of this application, Phillips Petroleum Company states the following:

1. Applicant is owner and operator of subject leases.
2. The subject leases are dedicated to a common beneficiary, the State of New Mexico, Common Schools.
3. All wells will be producing from a common source of supply.
