Gentlemen:

We are by this letter and enclosures making application for exception to Rule 309(a) of the New Mexico Oil Conservation Commission Rules and Regulations. We propose to commingle the Strawn production from whatever wells we successfully complete on our leases in Sections 30 and 31, T-19-S, R-32-E, Lusk Field, Lea County, New Mexico. As can be seen on the attached plat, we have room for five Strawn wells of which one is already completed and the second is drilling. According to our records there is a difference in ownership of overriding royalties and production payments which will require separate metering and sampling of production from each well. Since the two proposed wells in the S/2 of Section 31 have common ownership throughout, they will be handled through one metering sampling skid as shown on the attached schematic.

In conjunction with commingling we plan to install ACT to serve the central battery and have submitted the appropriate forms to your Hobbs District Office. Approval of both the commingling and ACT has been received from the purchaser. (See included letter.)

As per the regulations governing commingling, we have notified the royalty owners of our intentions by copy of this letter and enclosures. (See attached certified mail receipts.)

In view of the above presented and enclosed information, we respectfully request your approval of this project which we feel is in the best interests of all parties concerned.

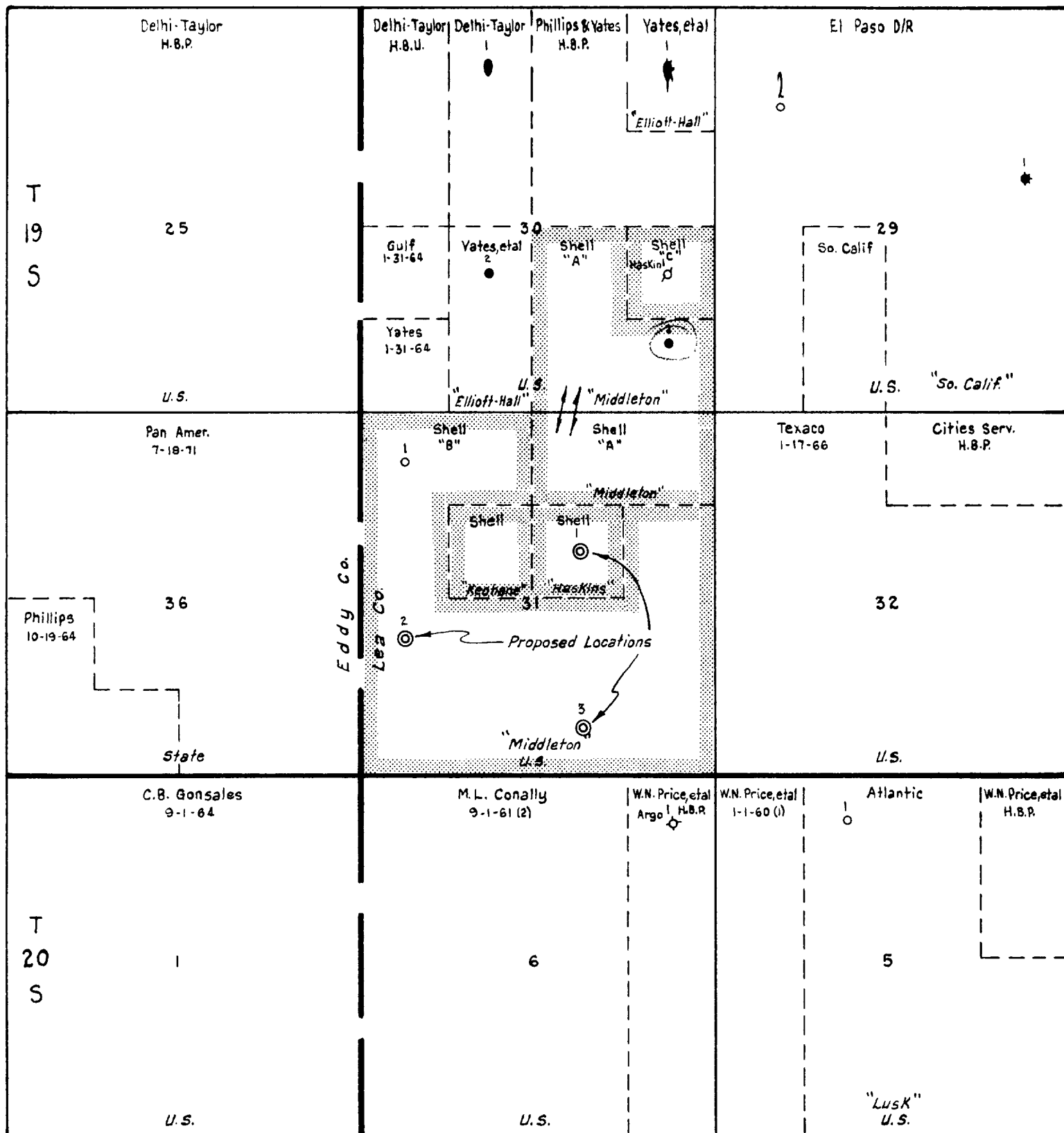

Dear Sir:

We acknowledge receipt of your drawings and specifications concerning installation of LACT facilities to serve your various leases in Section 30 and 31, T-19-S, R-32E, Lusk Field, Lea County, New Mexico.

We are agreeable to accepting custody of oil run from these leases on the basis of measurement by the LACT unit when installed as shown in your design specifications. The requirement for a BS&W monitor will be temporarily waived with the understanding that you agree to install a monitor and diverting valve should the BS&W content exceed two percent, and that our run ticket will show the percentage of BS&W actually obtained from the composite sample container even though it is in excess of two percent.

In order to synchronize the pipeline pump with your meter charge pump, we request that you provide a set of auxiliary contacts on the holding coil for remote control of the pipeline pump.

Run tickets will be issued monthly (or at other intervals if deemed necessary by our field superintendent).

Meter proving for field calibration of this LACT unit may be by any of the standard methods currently in use and shall be performed by Shell, or at their expense, at such intervals as may be mutually determined.

When installation of your equipment has been completed, please contact our Field Supervisor, Mr. W. R. Crabtree, telephone EX 3-8616 in Hobbs, New Mexico, who will assist in placing it in operation.
