Please cancel Administrative Order CTB-141 dated March 1, 1965, authorizing commingling of oil produced from the Tobac Pennsylvanian Pool on Humble's New Mexico State "BW" Lease, comprising the SE/4 of Section 16, T-8-S, R-33-E, Chaves County, New Mexico with oil production from the Tobac Pennsylvanian Pool on the New Mexico State "BX" Lease comprising the SW/4 and N/2 of Section 16, T-8-S, R-33-E.

Administrative Order CTB-141

Gentlemen:

Reference is made to your application dated February 24, 1965, for administrative approval of an exception to Rule 309-A of the Commission Rules and Regulations to permit the commingling of oil produced from the Tobac-Pennsylvanian Pool on your State of New Mexico "BW" Lease comprising the SE/4 of Section 16, Township 8 South, Range 33 East, Chaves County, New Mexico, with oil production from the Tobac-Pennsylvanian Pool on your State of New Mexico "BX" Lease comprising the SW/4 and N/2 of Section 16, Township 8 South, Range 33 East. It is our understanding that each of these leases has a common working interest and that the royalty interest is also common throughout, and that you therefore propose to allocate the production to each of the leases on the basis of periodic well tests.

Under the authority granted me pursuant to Rule 309 (b), you are hereby authorized to commingle the above-described production as proposed subject to the provision of the Commission "Manual for the Installation and Operation of Commingling Facilities."
