Gentlemen:

Reference is made to your application dated December 2, 1965, for administrative approval of an exception to Rule 309-A of the Commission Rules and Regulations to permit the commingling of oil produced from your State-32 Lease comprising the N/2 NE/4, S/2 NW/4, N/2 SE/4, and S/2 SW/4 of Section 32, Township 23 South, Range 38 East, and your Continental State lease comprising the N/2 NE/4 and N/2 SE/4 of Section 5, Township 24 South, Range 38 East, Stateline Ellenburger Pool, Lea County, New Mexico, after separately and continuously metering the production from each lease.

Under the authority granted me pursuant to Rule 309-B, Standard Oil Company of Texas is hereby authorized to commingle the above-described production as proposed, subject to the provisions of the Commission's "Manual for the Installation and Operation of Commingling Facilities," including the requirement that the production be metered with temperature compensated meters operated in conjunction with samplers, and provided further, that the meters shall be equipped with non-reset counters. Please notify the Hobbs District Office of the Commission at such time as this installation is complete in order that a field inspection may be made of the installation prior to putting it in operation.
