Gentlemen:

Reference is made to the application of Kern County Land Company for authority to commingle East Saunders Permo-Pennsylvanian production from its Etcheverry Unit Wells Nos. 1, 2, and 3 with East Saunders preduction from the Etcheverry Unit Well No. 4, after separately matering the production from Well No. 4 and the composite production from the other three wells. These metering facilities shall include temperature compensated positive displacement meters and strainers and samplers and are required insamuch as there is a variation in the beneficiary royalty ownership in the acreage dedicated to Wells Nos. 1, 2, and 3 and that dedicated to Well No. 4.

We have now received the consent of the Commissioner of Public Lands for the State of New Mexico and the consent of Pan American Petroleum Corporation, purchaser of the crude oil, to the aforesaid commingling installation.

Under the authority granted me pursuant to Rule 309-B, Kern County Land Company is hereby authorised to commingle the above-described production as proposed subject to the previsions of the Commission "Manual for the Installation and Operation of Commingling Facilities," including the requirement for non-reset counters on the meters. Please notify the Hobbs District Office of the Commission at such time as the installation is complete in order that an inspection may be made of the installation prior to putting it in operation.
