Reference is made to your recent request for administrative approval of an exception to Rule 309-A of the Commission Rules and Regulations to permit the commingling of Vacuum Glorieta production from your Vac Edge Unit Wells Nos. 1-G and 2-G in Section 5, Township 18 South, Range 35 East, with Glorieta production from your State 3-32 Lease comprising the NW/4 of Section 32, Township 17 South, Range 35 East, Lea County, New Mexico, after separately metering the Vac Edge production and determining the 3-32 production by means of the subtraction method.
