Reference is made to your application dated October 3, 1968, as amended October 17, 1968, for administrative approval of an exception to Rule 309-A of the Commission Rules and Regulations to permit the commingling of Vada-Pennsylvanian production from your State of New Mexico TUC Lease comprising the NE/4 of Section 30 and your State of New Mexico NGF Lease comprising the NW/4 of Section 30, Township 10 South, Range 34 East, Lea County, New Mexico, after separately metering and sampling the production from each lease.

Under the authority granted me pursuant to Rule 309-B, Monsanto Company is hereby authorized to commingle the above-described production as proposed, subject to the provisions of the Commission "Manual for the Installation and Operation of Commingling Facilities," including the requirement for non-reset counters on the meters and temperature-compensated meters. Gentlemen:

A Form C-106, Notice of Intention to Utilize Automatic Custody Transfer Equipment for the oil being sold from the TUC State Lease, Lea County, New Mexico, was filed with your district office in Hobbs, New Mexico, on October 16, 1968.

October 3, 1968, Monsanto Company requested approval from your office to commingle production from the three referenced leases in Section 30. This LACT equipment is designed to handle production from these three leases in the event commingling is approved. The LACT equipment will require a bad oil divert line which must return to a heater-treater. It is believed that a very small amount of bad oil will be diverted from the LACT unit; however, a meter will be installed in the bad oil divert line to insure proper allocation to each lease.

Attached is a revised schematic of the proposed equipment installation. On October 10, 1968, the Commissioner of Public Lands was notified of the revised equipment installation and the \$10.00 filing fee for commingling production was sent to his office.

Also enclosed is a plat showing these three leases and location of tank battery.

It is hoped the revised installation will meet with your approval.



Gentlemen:

In regard to your latter of September 30, 1968, please find enclosed \$10.00 for filing fee to commingle production of the subject leases. Permission to commingle production has been requested from the New Mexico Oil Conservation Commission, but has not been approved to date.

Approval to utilize Automatic Custody Transfer (ACT) equipment has been requested from the transporter, Service Pipe Line Company. New Mexico Oil Conservation Form C-106, Notice of Intention to Utilize ACT Equipment, will be filed after approval has been received from transporter. Utilization of ACT equipment on the lease will give greater assurance that lease allowables will be run to pipe line each month.

After investigating the possibility of using ACT equipment, it was noticed a bad oil divert line would be required from the unit to a heater-treater. It is believed that a very small amount of oil will be diverted from the ACT unit; however, a unter will be installed in the oil divert line to insure proper allocation of production to each lease.

Attached is a revised schematic of the proposed equipment installation. It is hoped this meets with your approval.

Gentlemen:

Monsanto Company is operator of three state leases consisting of the N/2 and SE/4 of Section 30-10S-34E, Lea County, New Mexico. The TUC State No. 1 in the NE NE of Section 30 was completed from the Bough "C" formation on September 25, 1968. We commenced drilling the MGF State No. 1 in the SW NW of Section 30 on September 22, 1968, as a Bough "C" test.

Monsanto is requesting administrative approval for exception to Rule 309-A to commingle into common storage facilities the oil production from the TUC State No. 1 and MGF State No. 1, assuming that the MGF State No. 1 is completed from the Bough "C" formation. We also plan to drill a Bough "C" test on the SE/4 of Section 30 and with your approval plan to commingle this production with the production from the MGF State No. 1 and TUC State No. 1 if this well is a successful Bough "C" oil producer.

Ownership of these leases is common throughout. The State of New Mexico owns the royalty and approval to commingle the production has been granted by the Commissioner of Public Lands (see attached letter). Attached is a list of overriding royalty owners, working interest owners and purchaser of the oil. By copy of this letter, these parties are being notified of our intention to commingle the production from these three leases.

We are submitting this request for your approval to commingle the production from the TUC State No. 1 and the MGF State No. 1 prior to completing the MGF State No. 1 so that an early decision may be obtained on this matter. A decision on this matter after the MGF State No. 1 is completed may delay production and revenue from the well for several weeks. Production equipment for the well cannot be ordered until we know if commingling will be allowed. Some of this equipment requires approximately six weeks delivery.

Attached is a plat showing the leases involved and the location of the TUC State No. 1 and MGF State No. 1. Also attached is a schematic of the proposed production equipment installation. Production and power oil from each well will go to individual heater-treaters. Water from each heater-treater will go to the water disposal system; the power oil and new oil from each heater-treater will be metered before being commingled at the power oil tank. The power oil going to each well will also be metered so that the new oil being produced from each well can be determined by subtracting the power oil meter reading from the heater-treater meter reading.

We hope that the proposed installation will meet with your approval. A decision at your earliest convenience will be appreciated. If you are unable to approve this request until after the wells are completed, could you possibly give us some expression as to whether our request contained herein would be an acceptable method of handling the production from these wells. If you have any questions or need additional information, please advise.


