Gentlemen:

References made to my telephone conservation of December 11, 1968, with Mr. Dan Nutter pertaining to the commingling of production from State Leases K-2443, K-5092 and OG-4632. As pointed out in previous correspondence, the working interest, overriding royalty interest and royalty interest in the three leases mentioned above are common throughout.

An attempt was made to meter the oil being produced from each lease prior to commingling. However, due to extreme difficulites encountered in connection with these meters we suffered a large amount of down time and in addition, meter malfunctions have resulted in gross measurement errors.

In discussing this problem with Mr. Nutter, he indicated the Oil Conservation Commission would grant approval to commingle this production without metering in accordance with the provisions outlined on page eight (8) of the Manual for the Installation and Operation of Commingling Facilities provided the State Land Office would also consent to commingling without metering. Subsequently, Mr. Ted Bilberry was contacted and he granted approval to commingle the oil from these leases without metering provided the wells are producing from a common pool. This approval is also covered in Mr. Bilberry's letter of October 17, 1968, of which a copy is attached.

Your consideration of our request to commingle the production from these three leases without metering would be appreciated. In lieu of metering, New Mexico Oil Conservation Commission

facilities will be provided for testing each of the wells on these leases at least once a month.
