Gentlemen:

Reference is made to your application dated April 28, 1969, for administrative approval of an exception to Rule 309-A of the Commission Rules and Regulations to permit the commingling of Vada-Pennsylvanian production from your Wolf Federal lease comprising the SE/4 of Section 5, and your Coll Federal Com. lease comprising the NE/4 of Section 8, both in Township 9 South, Range 35 East, Lea County, New Mexico, after separately metering the production from each lease.

Under the authority granted me pursuant to Rule 309-B, Tenneco Oil Company is hereby authorized to commingle the above-described production as proposed, subject to the provisions of the Commission "Manual for the Installation and Operation of Commingling Facilities," including the requirement for non-reset counters on the meters and temperature-compensated meters. Please notify the Hobbs District Office of the Commission at such time as this installation is complete in order that an inspection may be made thereof.

Figure 1. The effect of the concentration of the *Agrobacterium* suspension on the transformation efficiency of *Agrobacterium* strains. The *Agrobacterium* strains were grown in the YEA medium for 24 h at 28°C. The cell concentration of the strains was adjusted to 1.0 × 10⁸ cells/ml. The cell suspension was mixed with the plant tissue and the transformation efficiency was determined. The results were expressed as the mean ± SD of three independent experiments. The asterisks indicate the significant difference between the strains at the same concentration of the cell suspension.
