As an exception to the requirements of Rule 309-A of the Division Rules and Regulations, and pursuant to the provisions of Rule 309-C, the above named company is hereby authorized off-lease storage and measurement for Loco Hills-Paddock (96718) Pool production from the following lease:

Lease: Brigham H (State Lease No. LC-029342-H)  
Description: NW/4 SW/4 of Section 21, Township 17 South, Range 30 East, NMPM,  
Eddy County, New Mexico.

The aforementioned production is to be transported prior to measurement and storage at the Berry A Federal Well No. 7 (State of New Mexico Lease LC-054988-A) off lease storage and measurement facility located in Unit C of Section 22, Township 17 South, Range 30 East, NMPM, Eddy County, New Mexico.

NOTE: This installation shall be installed and operated in accordance with the applicable provisions of Rule 309-A and 309-B of the Division Rules and Regulations and there shall be no intercommunication of the handling, separating, treating or storage facilities designated to the above lease.

FURTHER: The operator shall notify the Artesia district office of the Division prior to implementation of the commingling process.
