Exxon requests permission to surface commingle production from all current and future oil and gas wells on our J. L. Greenwood and N. G. Penrose leases and well test allocate the lease production to each well completion for reporting purposes. This will enable us to keep the amount of equipment needed to efficiently operate these leases to a minimum. This does not set a precedent. Approvals (copies attached) to well test allocate all the wells on our New Mexico S State and F. F. Hardison B leases have been previously granted.

The pools from which the subject leases produce and a complete list of wells are shown on the attached spreadsheet. Production from the J. L. Greenwood lease is surface commingled per Commingling Order PC 602 and production from the N. G. Penrose lease is commingled per Commingling Order PC 521.

Our request to limit the equipment needed on the lease and well test allocate is based upon the following factors:

- There is no diversity in Royalty, Overriding Royalty or Working Interest.
- Limiting the amount of equipment will assist in extending the profitability and life of the leases.
- The future cost of setting meters and installing meter runs would adversely affect profitability.
- The wells are currently marginal in production and profitability.
- The GOR fluctuates and can easily exceed 50,000.
- None of the wells produce the field allowable.
- Separate metering furnishes no additional information necessary to determine the production volume for these leases.
