Meridian is asking for three pools, South Corbin Bone Spring, South Corbin Wolfcamp, and the West Corbin Delaware as there are intentions to recomplete to the other zones.

All the production is stored in the Federal 21 battery located in Unit Letter K of Section 21, T18S, R33E, Lea County, New Mexico. All the production is metered prior to leaving its own lease. The Tijeras State production is stored in a single tank battery located in Unit Letter K of Section 21, T18S, R33E, Lea County, New Mexico. There is a double meter lact unit on the location. The production from the Federal Leases is run through one (1) meter and the Tijeras State through the other. Subsequently, the production is transported by Texas-New Mexico Pipeline.

Meridian is 100% working interest owners for all the wells in the leases referenced above.

The proposed commingling of production is in the interest of conservation and will not result in reduced royalty or improper measurement of production.

The proposed commingling is necessary for continued operation of the above referenced federal leases.

WE UNDERSTAND THAT THE REQUESTED APPROVAL WILL NOT CONSTITUTE THE GRANTING OF ANY RIGHT OF WAY OR CONSTRUCTION RIGHTS NOT GRANTED BY THE LEASE INSTRUMENT, AND IF APPLICABLE, WE WILL SUBMIT WITHIN 30 DAYS AN APPLICATION FOR RIGHT OF WAY APPROVAL TO THE BLM'S REALTY SECTION IN YOUR OFFICE IF WE HAVE NOT ALREADY DONE SO.
