Reference is made to your application letter of May 8, 1997. In your letter you have requested our approval to install a gas gathering line from the Buena Suerte 32-L Well No. 1 located in the NW/4SW/4, Section 32-26N-11W and terminating at a field compressor site and Central Delivery Point at the Gallegos Com Well No. 5 located in the NW/4SE/4 of Section 32-26N-11W. It is our understanding that you will allocate the sales and production volumes for each well based on the sales meter set at the outlet of the compression located on the Com 5 location and standard orifice meters located at the 5-K and the 32-L wells.

Please be advised that the Commissioner of Public Lands has this date granted approval to your proposed request. Our approval is given with the understanding that the Commissioner of Public Lands reserves the right to amend or withdraw his approval should this operation prove to be unprofitable to the state at any time in the future. Our approval is subject to like approval by the New Mexico Oil Conservation Division and the Bureau of Land Management.



We have received your correspondence and subsequent documentation applying for an addendum to a previously approved central delivery point (CDP). On October 5, 1993, approval to surface commingle the No. 5 Gallegos Com and the No. 2 Gracia Navajo 5-K. No. 1 Buena Suerte 32-L will be added to the system. The manner of allocation will be the same as previously approved. An allocation meter has been installed on the No. 1 Buena Suerte. With the addition of the Buena Suerte well, gas produced for the No. 5 Gallegos Com will be calculated by taking the difference of the Sales meter volume and the allocation meter volumes, fuel use, and any purged or vented gas.
