Dear Ms. Wrotenbery, Mr. Powell, and Mr. Otteni:

In the captioned application we did not describe how oil production from wells connected to the Rusty Chacra Gas Gathering System would be handled. There are currently six wells producing from the Gallup formation (Alamito, Rusty and South Rusty Gallup oil pools) and during 1997 production averaged 1.0 BOPD plus 15.0 MCFD per well. There is no oil production associated with the 29 wells producing from the Chacra formation.

All oil production will be separated, stored and sold at each well site. There will be no commingling of oil production. Only natural gas produced in association with the oil will enter the Rusty Chacra Gas Gathering System and be subject to our application for surface commingling and off-lease measurement.

NOTE: The commingled natural gas production shall be delivered to a CDP sales meter on El Paso Field Service's Pipeline in the SE/4 NW/4 of Section 12, Township 22 North, Range 7 West, NMPM, Sandoval County, New Mexico.

NOTE: Oil production shall be separated, stored, and sold at each wellsite.

NOTE: This installation shall be installed and operated in accordance with the applicable provisions of Rule 309-B of the Division Rules and Regulations and the Division "Manual for the Installation and Operation of Commingling Facilities." It is the responsibility of the producer to notify the transporter of this commingling authority.

FURTHER: The operator shall notify the supervisor of the Aztec district office prior to implementation of the commingling process.

PROVIDING: <u>Validation of this authority shall be accomplished by like approval by the U.S.</u> Bureau of Land Management and New Mexico Commissioner of Public lands.
