Re: Application For Administrative Approval For Conversion of Two Unit Wells to Water Injection Wells, Caprock Queen Water Flood Project, Chaves County, New Mexico

Gentlemen:

As provided for in Order No. R-1456, John H. Trigg, as operator of a pilot water flood in the Caprock Queen Field, Chaves County, New Mexico, requests administrative approval for conversion of the following unit wells to water injection wells:

Well No. 5-4, SEZSEZ Section 4, Township 14 South, Range 31 East.

Well No. 7-4, SEXNEZ Section 4, Township 14 South, Range 31 East.

John H. Trigg has been notified by Cities Service Oil Company that in the Drickey Queen Sand Unit, water flood wells numbered 17, 19 and 21 have experienced a substantial response to the water flood. John H. Trigg wells numbers 5 and 7 are offsetting, or diagonally offsetting, the aforementioned Cities Service wells. Cities Service Oil Company has received approval from the Oil Conservation Commission to convert wells numbers 17 and 21 to injection wells.

When John H. Trigg wells 5 and 7 are converted to injection wells they will comply with our line agreement with Cities Service Oil Company whereby they have converted wells 17 and 21 to injection wells. A copy of the line agreement is on file with the Oil Conservation Commission. Cities Service Oil Company has submitted Form C-116 setting out the increased response they have had on wells 17, 19 and 21.

We should like to request that the State Engineer file a letter of waiver with Mr. A. L. Porter, Jr., Member & Secretary of the Oil Conservation Commission. So far as is known there are no fresh water sands underlying Sections 4, 9 and 34 in our project area. All water that is injected will be through tubing with a packer set immediately above the Queen Sand zone.
