## ADMINISTRATIVE ORDER OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 701, Newmont Oil Company has made application to the Commission on February 6, 1961, for permission to expand its Grayburg-San Andres Water Flood Project in the Square Lake Pool, Eddy County, New Mexico.

NOW, on this 21st day of February, 1961, the Secretary-Director finds:

- 1. That application has been filed in due form.
- 2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
- 3. That no objection has been received within the waiting period as prescribed by Rule 701.
- 4. That the proposed injection wells are eligible for conversion to water injection under the terms of Rule 701.
- 5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
  - 6. That the application should be approved.

## IT IS THEREFORE ORDERED:

That the applicant, Newmont Oil Company, be and the same is hereby authorized to inject water into the Lower Grayburg and Upper San Andres formations through the following wells for purposes of secondary recovery, to-wit:

Vickers Well No. 6 located in the SW/4 SE/4 of Section 19 and Bruning Unit Well No. 3 located in the SW/4 NE/4 of Section 29, both in Township 16 South, Range 31 East, NMPM.

PROVIDED HOWEVER, that applicant shall inject water through tubing with packers set well below the top of the cement outside the 5½-inch casing in aforesaid wells.
