# ADMINISTRATIVE ORDER OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 701, Cities Service Petroleum Company has made application to the Commission on February 19,1962, for permission to expand its Drickey Queen SandUnit Water Flood Project in the Caprock Queen Pool, Chaves County, New Mexico.

NOW, on this 6th day of March, 1962, the Secretary-Director finds:

- 1. That application has been filed in due form.
- 2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
- 3. That no objection has been received within the waiting period as prescribed by Rule 701.
- 4. That the proposed injection wells are eligible for conversion to water injection under the terms of Rule 701.
- 5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
  - 6. That the application should be approved.

## IT IS THEREFORE ORDERED:

That the applicant, Cities Service Petroleum Company, be and the same is hereby authorized to inject water into the Queen formation through the following described wells for purposes of secondary recovery, to wit:

Tract 16 Well No. 1, NW SW Section 35, Township 13 South, Range 31 East

Tract 37 Well No. 1, SE NW Section 35, Township 13 South, Range 31 East

Tract 37 Well No. 3, NW NE Section 35, Township 13 South, Range 31 East
