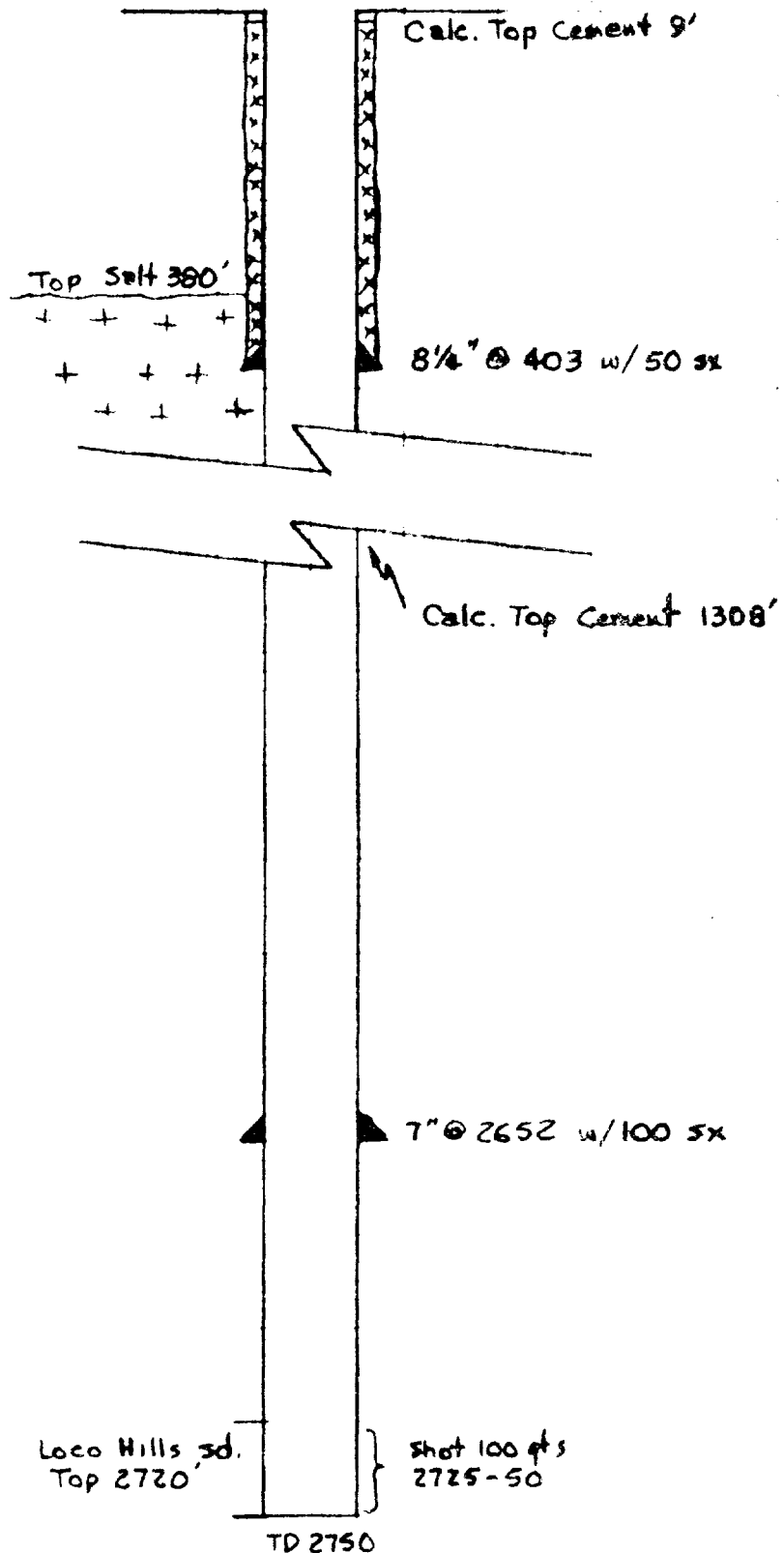

Gentlemen:

We hereby request administrative approval for conversion of Newmont's Canfield "A" No. 7 to water injection. This well is located in Newmont's West Loco Hills Unit, 1270 FNL and 1370 FWL, Sec. 7-18S-30E, under Order R-2178B, dated June 14, 1962, approving stage development of the West Loco Hills Unit. This well will be designated as Well No. 1-7. Conversion will be in conformance with an efficient pattern.

All pertinent completion information is presented on the attached sketch.

Fresh water was encountered at 305 feet while drilling. Inasmuch as the 8 1/4" surface pipe was set below the top of the salt, this horizon is adequately protected. We plan, therefore, to inject down 7" casing.

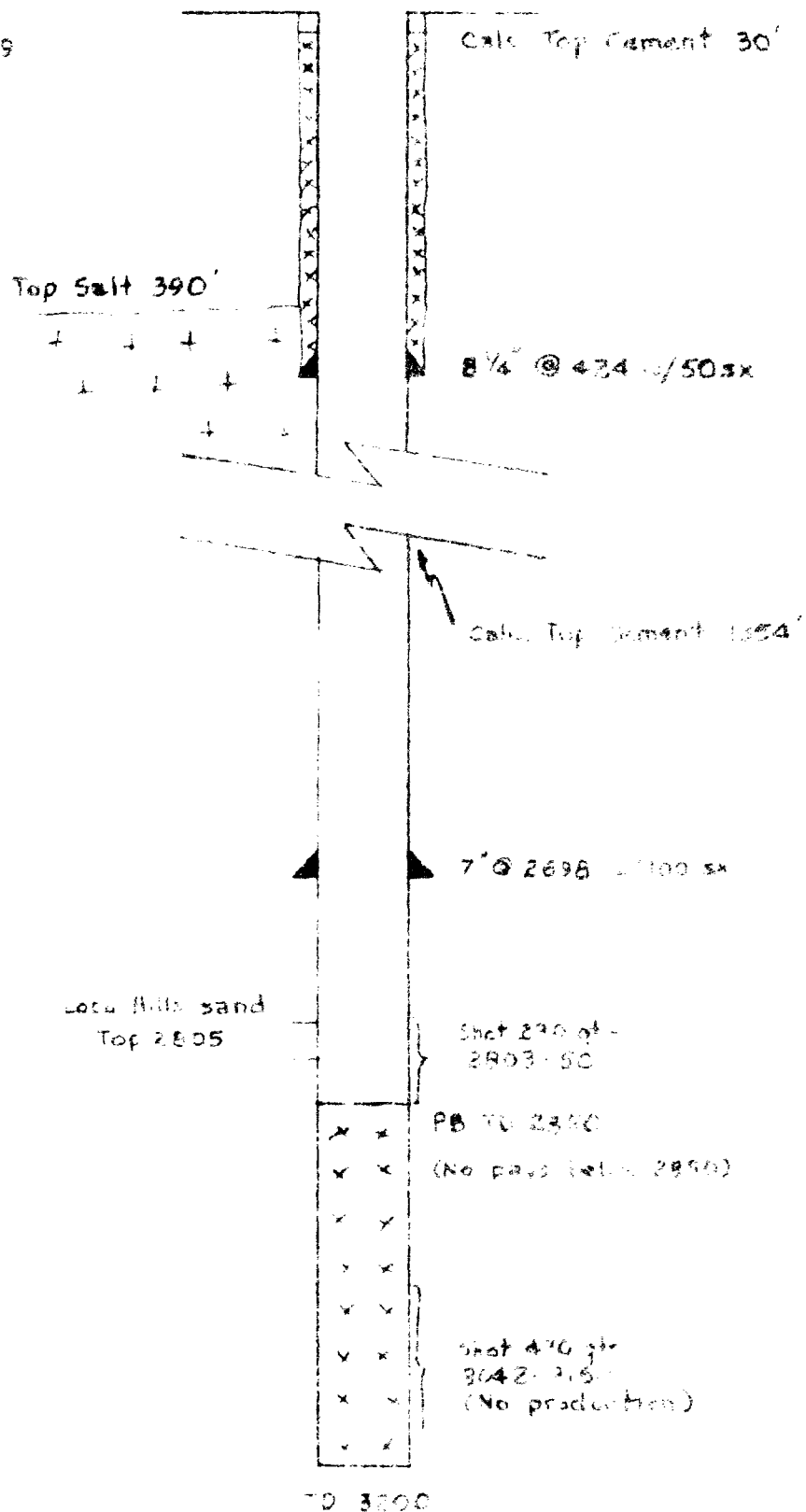
