Newmont Oil Company hereby requests administrative approval to convert the following well in Loco Hills Sand Unit Waterflood to water injection:





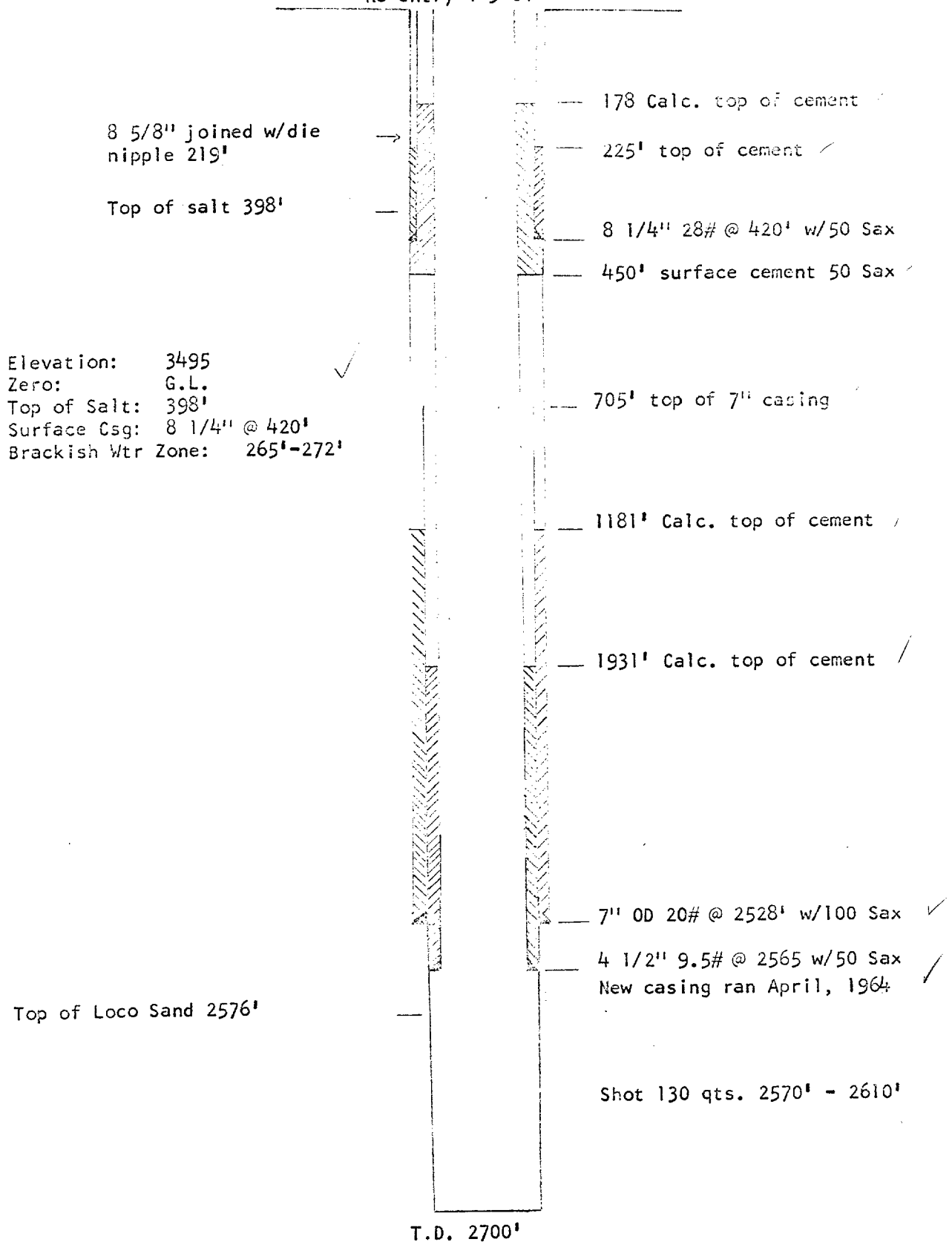

Reference is made to the application of Newmont Oil Company which seeks administrative approval to convert their well No. 6 in Tract 17-B, Sec. 10, T. 18 S., R. 29 E., to water injection.

This office offers no objection to the granting of the application, provided the casing will withstand a pressure of 300 psi in excess of the maximum injection pressure; that the results of the casing test be furnished the Oil Conservation Commission and this office; and that periodic tests are conducted during the life of the flood and results thereof filed with the Oil Conservation Commission and this office, indicating that the fluids are being controlled satisfactorily.


