ADMINISTRATIVE ORDER
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 701, Mobil Oil Corporation has made application to the Commission on March 8, 1967, for permission to expand its Vacuum Water Flood Project in the Vacuum Grayburg-San Andres Pool, Lea County, New Mexico.

NOW, on this 24th day of March, 1967, the Secretary-Director finds:

1. That application has been filed in due form.
2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
3. That no objection has been received within the waiting period as prescribed by Rule 701.
4. That the proposed injection wells are eligible for conversion to water injection under the terms of Order No. R-1244.
5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
6. That the application should be approved.

IT IS THEREFORE ORDERED:

That the applicant, Mobil Oil Corporation, be and the same is hereby authorized to inject water into the Grayburg-San Andres formation through the following described wells for purposes of secondary recovery, to wit:

State Bridges Well No. 76 located in Unit O of Section 11,
State Bridges Well No. 51 located in Unit M of Section 12,
State Bridges Well No. 83 located in Unit O of Section 12,
State Bridges Well No. 46 located in Unit C of Section 13,
State Bridges Well No. 24 located in Unit M of Section 13,
State Bridges Well No. 40 located in Unit A of Section 14,
State Bridges Well No. 21 located in Unit A of Section 23,
State Bridges Well No. 7 located in Unit G of Section 23,
State Bridges Well No. 43 located in Unit I of Section 23,
State Bridges Well No. 20 located in Unit E of Section 24,
all in Township 17 South, Range 34 East, NMPM.

PROVIDED HOWEVER, That applicant shall inject water through tubing with packers set well below the top of the cement surrounding the production strings of the above described wells.

DONE at Santa Fe, New Mexico, on the day and year hereinabove designated.
