# ADMINISTRATIVE ORDER OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 701, Cities Service Oil Company, has made application to the Commission on January 8, 1968, for permission to expand its Southeast Maljamar Grayburg-San Andres Unit Water Flood Project in the Maljamar Grayburg-San Andres Pool, Lea County, New Mexico.

NOW, on this 23rd day of January, 1968, the Secretary-Director finds:

- 1. That application has been filed in due form.
- 2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
- 3. That no objection has been received within the waiting period as prescribed by Rule 701.
- 4. That the proposed injection wells are eligible for conversion to water injection under the terms of Rule 701.
- 5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
  - 6. That the application should be approved.

## IT IS THEREFORE ORDERED:

That the applicant, Cities Service Oil Company, be and the same is hereby authorized to inject water into the Grayburg-San Andres formation through the following described wells for purposes of secondary recovery, to wit:

Tract 2 Well No. 5 located in Unit B and Tract 1 Well No. 1 located in Unit J, both in Section 30, Township 17 South, Range 33 East, NMPM.

PROVIDED HOWEVER, That applicant shall inject water through tubing with packers set in the production casing just above the injection zone in said wells.

Done at Santa Fe, New Mexico, on the day and year hereinabove designated.
