Gentlemen:

Anadarko Production Company hereby requests administrative approval of the Oil Conservation Commission of the State of New Mexico to convert to water injection Tract 8 - Well No. 31 at a location 2310' from the south line and 1980' from the west line of Section 4 -T18S-R29E and Tract 10-Well No. 16 at a location 1980' from the south line and 660' from the west line of Section 9-T18S-R29E on the referenced Unit. These wells are proposed as substitutions for two (2) wells authorized for water injection purposes by Order R-3628 and R-3628-A, Tract 8-Well No. 34 at a location 1980' from the south line and 1980' from the west line of Section 4-T18S-R29E and Tract 10-Well No. 36 at a location 1330' from the south line and 10' from the west line of Section 9-T18S-R29E.

Order (3) of Order R-3628-A gives the Secretary-Director of the Commission authority to substitute water injection wells for those previously authorized on the referenced Unit by Order R-3628 and R-3628-A at orthodox and unorthodox locations provided certain specified conditions are met.

These conditions have been met as follows:

- (1) Neither well is located within 330' of the outer boundary of the Unit nor within 10' of any quarter-quarter section or subdivision inner boundary.

Regulations have been complied with by the enclosure herewith of (1) a plat showing the proposed water injection wells and offset operations, (2) a log of each of the proposed water injection wells, and (3) a diagrammatic sketch of the proposed water injection well completions on which we have indicated the zone to be open for injection and the type and quantity of water to be injected.

- (3) A copy of this application has been furnished Newmont Oil Company and J. Cleo Thompson as offset operators with a request that they advise the Commission of their waiver of any objections at their earliest convenience.

The conversion of these wells to water injection is essential to the maximum recovery of oil from the Zone 4 of the Grayburg (Loco Hills Sand) under the Far West Loco Hills Sand Unit.

Your approval at your earliest convenience will be appreciated.

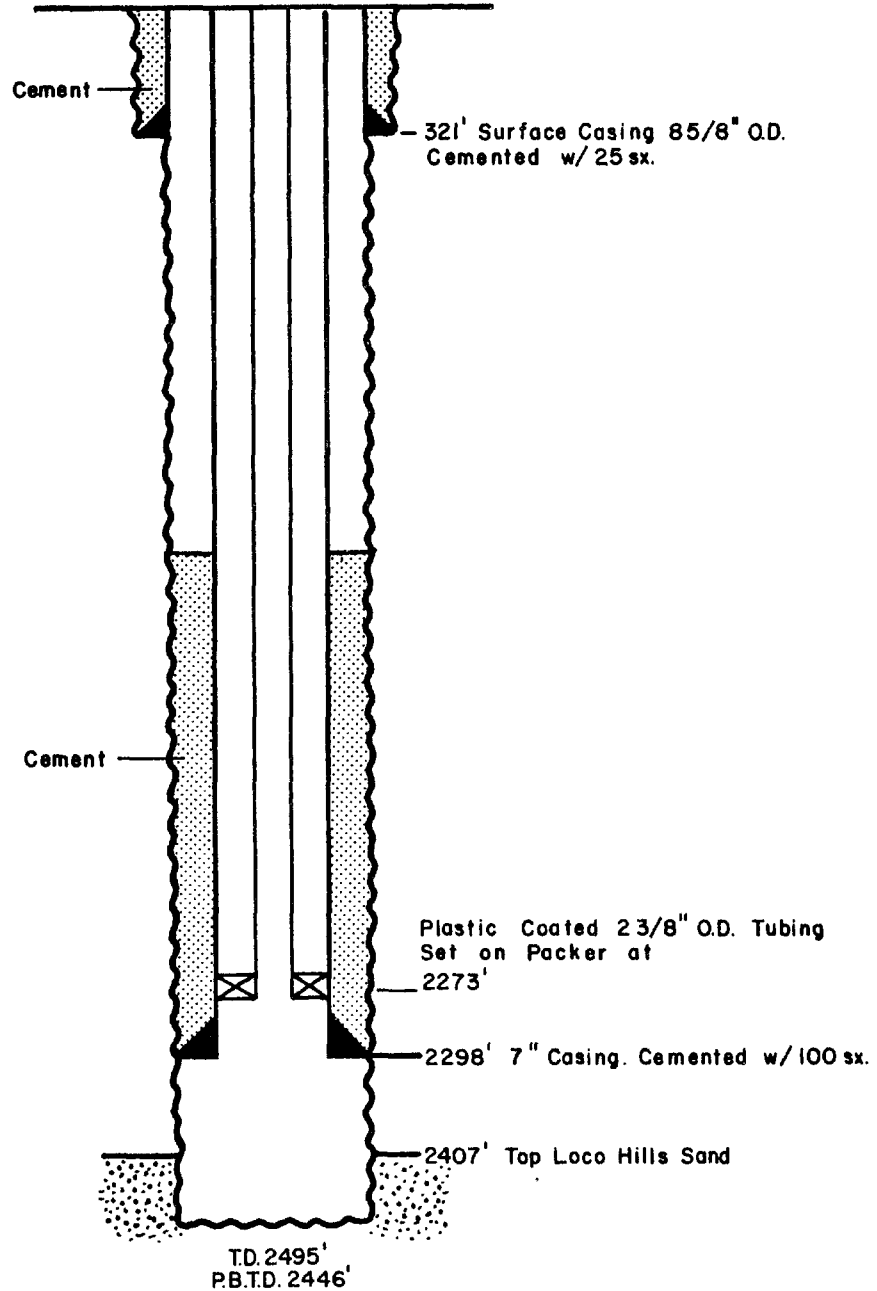

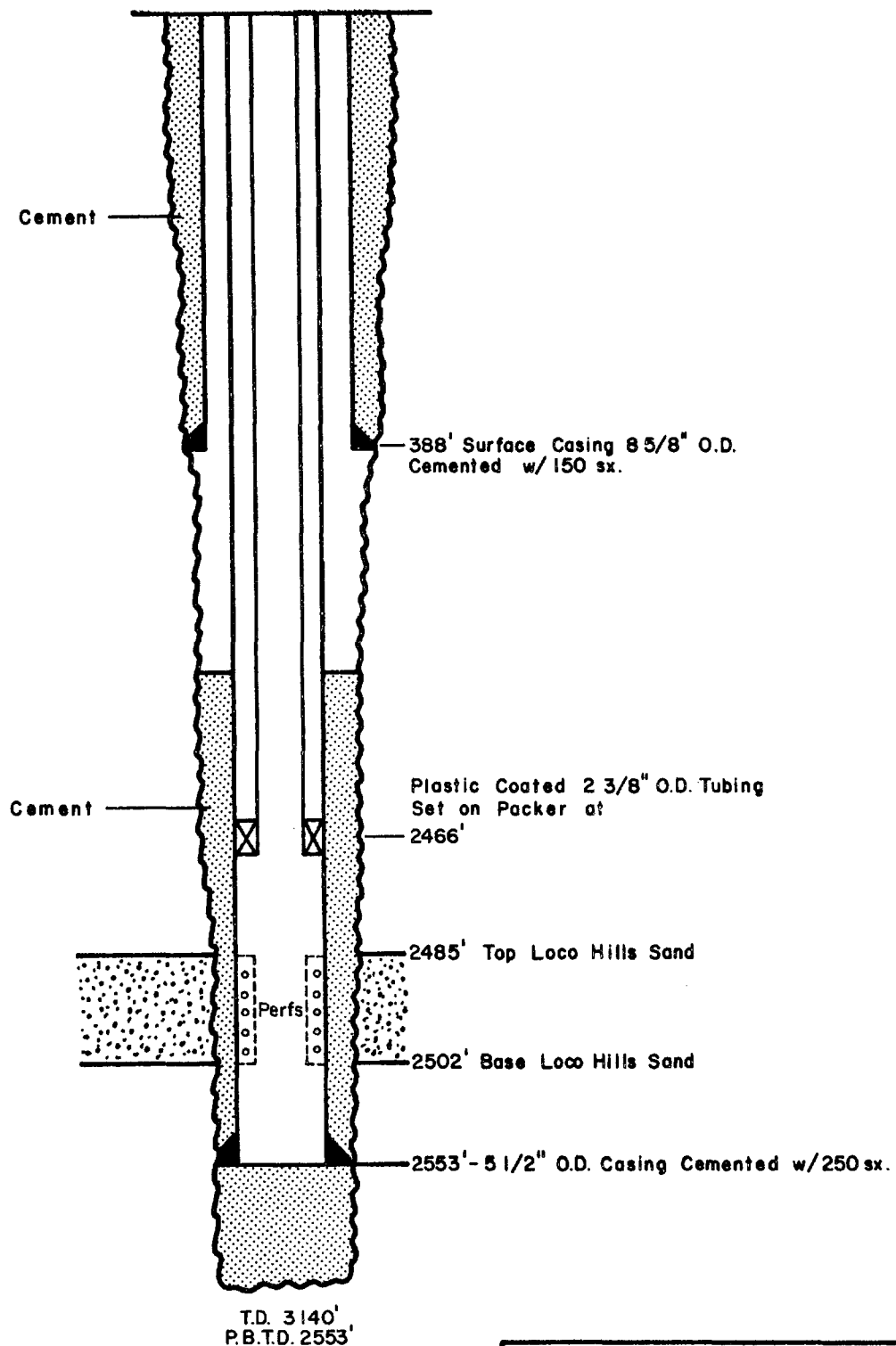

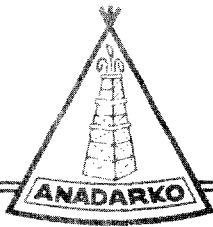
