Amerada Hess Corporation hereby requests administrative approval to expand the Langlie Mattix Woolworth Unit in accordance with Order No. R-2197-A dated September 17, 1969. Approval is requested to convert three (3) wells to injection and drill three (3) injection wells as follows:

Convert: L.M.W.U. Well No. 113 located in Unit P, SE/4,SE/4, Sec. 33
L.M.W.U. Well No. 804 located in Unit D, NW/4,NW/4, Sec. 33
L.M.W.U. Well No. 902 located in Unit L, NW/4,SW/4, Sec. 33

Drill: L.M.W.U. Well No. 165 located in Unit N, SE/4,SW/4, Sec. 34
L.M.W.U. Well No. 166 located in Unit P, SE/4,SE/4, Sec. 34
L.M.W.U. Well No. 003 located in Unit N, SE/4,SW/4, Sec. 33

These wells along with existing injection wells are shown on the attached plat. The proposed injection wells are offsets to producing wells which have experienced substantial response to water injection.

Injection will be into the Langlie Mattix zone with expected stabilized rates of 300-600 bwpd. The primary source of injection water is the San Andres in addition to produced water and waste water from El Paso Natural Gas Company's processing plants.

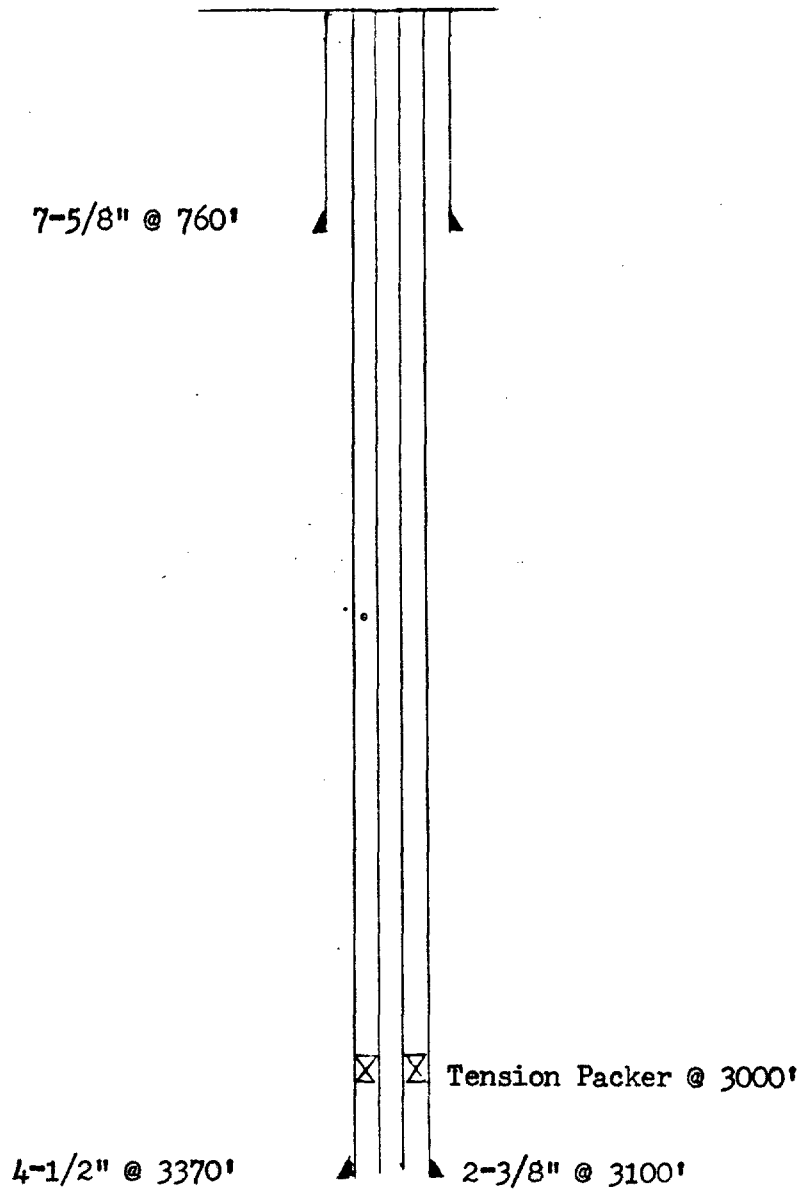
