## ADMINISTRATIVE ORDER OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-3550-A, Champlin Petroleum Company has made application to the Commission on April 23, 1971, for permission to expand its Chaveroo State 32 Water Flood Project in the Chaveroo-San Andres Pool, Roosevelt County, New Mexico.

NOW, on this 8th day of May, 1971, the Secretary-Director finds:

1. That application has been filed in due form.

2. That satisfactory information has been provided that all offset operators have been duly notified of the application.

3. That no objection has been received within the waiting period as prescribed by Order No. R-3550-A.

4. That the proposed injection well is eligible for conversion to water injection under the terms of Order No. R-3550-A.

5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.

6. That the application should be approved.

IT IS THEREFORE ORDERED:

That the applicant, Champlin Petroleum Company, be and the same is hereby authorized to inject water into the San Andres formation through the following described well for purposes of secondary recovery, to wit:

State 32-7-33 Unit Well No. 13 located in Unit D of Section 32, Township 7 South, Range 33 East, NMPM.

PROVIDED HOWEVER, that the applicant shall inject water through tubing with a packer set at approximately 4260 feet.
